#### CARRIED UNANIMOUSLY

A) Ms. Elsie Dean, 5285 Empire Drive, Burnaby appeared before Council on behalf of the Vancouver Chapter of the Council of Canadians to discuss issues pertaining to the Multilateral Agreement on Investment (MAI).

Ms. Dean introduced the following two matters relating to trade and investment agreements and their implications for the City of Burnaby:

- The industry/government round table discussion for the simplification of the World Trade Organization Agreement on Government Procurement;
- The leaked document from the European Union Commission on Investment Regulation and the introduction into the World Trade Organization of a Prototype of the Multilateral Agreement on Investment.

The speaker recommended that Burnaby Council pursue the issues with the Federal Government with the view to initiating a dialogue with the Federal and Provincial Governments so that local government has input into an expanded agreement on procurement and further, urge the Federal Government to create the framework for any local government concerns to be incorporated into a cost/benefit analysis of an expanded agreement on procurement.

The second area of concern addressed by the delegation was the agreement of the Canadian, European Union, Japanese and now United States MAI negotiators' proposal to take the failed MAI like treaty into the world trade organization when it meets in Seattle, Washington in December of this year. The B.C. Legislative Commission will conduct the public phase of the Provincial Hearings into the MAI in Vancouver on 1999 March 11 at the University of British Columbia. Ms. Dean urged Council to appear and submit a paper on their concerns about future negotiations on MAI like agreements and the Federal Government's inclusion of local governments in its agreement on government procurement in the World Trade Organization.

The Environment & Waste Management Committee submitted a report providing a summary of the 1998 Waste Reduction Program and outlining the proposed 1999 Program. The Committee advised that the "Think Three" and "Next Step is Clear" initiatives together with the apartment toter system, depot operations

and the education programs have provided residents with alternatives for waste reduction and decreased the volumes of garbage in the single/duplex family waste stream by 40% from 1989 levels. In 1999, the Committee indicated that it will continue to seek more effective means of further reducing the waste stream in an effort to meet or exceed the goal of the Regional Solid Waste Management Plan. The 1999 plan will build on the success of past programs to enhance participation with an increased emphasis on reaching out to ethnic communities.

  - e. The granting of any necessary easements and covenants.
  - f. The dedication of any rights-of-way deemed requisite.
  - g. The undergrounding of existing overhead wiring abutting the site.
  - h. The retention of identified existing trees on the site, their protection by registration of a section 219 Covenant, submission of a written undertaking to ensure that all site areas identified for preservation of existing trees are effectively protected by chain link

fencing during the whole course of site and construction work, and deposit of sufficient monies to ensure the protection of identified existing trees, to be refunded a year after release of occupancy permits, upon satisfactory inspection.

- i. Additional planting as deemed appropriate by the City's Landscape Inspector in the covenanted conservation area.
- j. The approval of the Ministry of Transportation and Highways to the rezoning application.
- k. The deposit of the applicable GVS & DD sewerage charge.
- I. The provision of facilities for cyclists in accordance with Section 3.9 of this report.
- m. The submission of a suitable engineered design for an approved on-site sediment control program.
- n. Confirmation of the commencement of construction and completion schedule of the Discovery Place Multi-Tenant Facility (Rezoning Reference #61/97).
