MOVED BY COUNCILLOR EVANS: SECONDED BY COUNCILLOR YOUNG:

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

In responding to a request from Ms. Parvin Chami, Council agreed to bring forward Delegation Item 2(B) at this time.

B) Ms. Beata Chami, 3710 Kalyk Avenue, Burnaby appeared before Council to discuss the trees behind Green Tree Village, located in Forest Lawn Cemetery. Ms. Chami advised that on 1998 December 14, Mrs. Parvin Chami came to City Council to request that they not allow developers to cut down the trees. Ms. Chami advised that Parvin Chami has been the Chair of the *Friends of Discovery Park* in the past and, as such, went to Council to advise of her concerns.

In concluding her comments, Ms. Chami suggested that Council had no right to respond to Mrs. Parvin Chami the way they did and that she deserved an apology.

A) Mrs. Parvin Chami, 3710 Kalyk Avenue, Burnaby appeared before Council and advised that, as a Community Activist, she was concerned regarding the loss of green space, preservation of wildlife, noise pollution, air quality and streams. Mrs. Chami indicated that her concerns related to proposed developments in other parts of the City as it relates to her backyard. The speaker advised that protecting the environment should be a top priority and that citizens should have the right to raise their concerns before Council.

With respect to the Forest Lawn Cemetery Master Plan, Mrs. Chami inquired if the setback of 6 meters could be increased to at least 18 meters in order to protect the wildlife corridor and provide a visual screen for adjoining properties. Further, Mrs. Chami questioned the type of vegetation that would be planted and if there would be an environmental monitor to oversee the development.

With respect to Discovery Park, the speaker questioned if the proposed new bylaws will apply to other areas such as Discovery Park Willingdon site and if the tree bylaw will be amended to prevent the loss of green space in Burnaby.

In closing, Mrs. Chami requested Council to restrict development in Discovery Park, and in particular lot M and lot A and requested that Council use the same standard as proposed for the Forest Lawn Cemetery development to preserve the Discovery Park trees. Mrs. Chami suggested that anything less would result in a double standard.

C) Mr. Bill Duncan, Business Representative for the United Brotherhood of Carpenters and Joiners of America Union Local 1995, #204 - 2806 Kingsway, Vancouver, B.C. appeared before Council to request that Council support a move to encourage condominium owners to move as quickly as possible to examine their properties and undertake repair and restoration arising from the onset of the Lower Mainland's leaky condominium crisis. The delegation further requested that City Council join with the carpenters and homeowners in lobbying the Homeowner Protection Office to establish effective contractor licensing, trades qualification standards and warranty systems for the potential volume of needed restorative construction in Burnaby, and the remarkable speed with which wood rotting basidiomycetes consume frame structures, further delays to exploration and resolution of the problem could seriously undermine the tax base of the community and the welfare of families.

Councillor Rankin returned to the Council Chamber at 7:20 p.m. and took his place at the Council table.

In concluding his presentation, Mr. Duncan put forward the following recommendations for Council's consideration:

- 1. THAT City Council communicate immediately to the citizens of the community the importance of examining their wood frame multi-residential properties to determine the extent of possible water damage.
- 2. THAT City Council join with the Carpenters' Union and homeowner groups in lobbying the Minister of Municipal Affairs and the Homeowner Protection Office to establish a high standard of general and sub contractor licensing, trades qualification standards, and meaningful warranty systems for the restoration industry as soon as possible.

Councillor Corrigan retired from the Council Chamber at 7:45 p.m.

MOVED BY COUNCILLOR EVANS: SECONDED BY COUNCILLOR JOHNSTON:

"THAT the comments and issues raised by the delegation be **REFERRED** to staff for report."

CARRIED UNANIMOUSLY

D) Ms. Sylvia Raschke, 3890 Garden Grove Drive, Burnaby appeared before Council on behalf of the Greentree Village residents to discuss issues pertaining to the City Planning report on the Forest Lawn Cemetery Master Plan. Ms. Raschke advised that it was her intention to discuss the report of the Director Planning and Building and raise some additional issues that have not been addressed in the report.

Councillor Corrigan returned to the Council Chamber at 7:52 p.m. and took his place at the Council table.

Ms. Raschke advised that the residents are pleased that a recommendation has been made to increase the setback for all uses on lands zoned P4 Cemetery District. However, there is a concern that 20 feet will not be sufficient, especially in the areas where there is a steep rise parallel to Garden Grove Drive. The Planners report states that the landscaping requirements will be on a site specific basis and the speaker questioned what mechanism will be used to address individual site landscaping.

In terms of appropriate landscaping within the required setback areas, Ms. Raschke indicated that the Planners report states that the landscape buffer provides an opportunity to preserve mature trees where it is appropriate. In the

November 16, 1998 report to Council, the Burnaby Arborist recommended that at least 50 percent of the existing width be protected in order to preserve the integrity of the forested area and prevent trees from being blown over.

Therefore, the speaker questioned if a 20 foot wide setback would be wide enough to support existing trees, given that the Arborist recommends that 50 percent of the width needs to be protected. Further, Ms. Raschke asked if new trees will be planted in setback areas where there are currently no trees.

Another concern raised by the Greentree Village residents was the absence of specific height regulations/recommendations of the landscaping of the setback areas. The speaker indicated that the homes in Greentree Village are primarily two storey and the steepness of the slope along the western property line means that any structures on Forest Lawn property will easily be visible to homeowners living at the bottom of the slope. Ms. Raschke inquired if, under the proposed bylaw, will the landscape buffer provide adequate privacy for residents bordering on the Forest Lawn property.

The last concern raised by the Greentree Village residents referred to the internment structures known as "Imperial Gardens" on the northeast slope of the cemetery which was not shown on the Master Plan submitted to Council. According to Forest Lawn Management, these structures are not above ground and therefore do not require building permits. Ms. Raschke suggested that the structures look like bunkers and the overall view of these buildings is very unsightly and therefore questioned if camouflaging these structures will be addressed.

 - 1. <u>Provincial Liquor Policy Review</u>

The City Manager submitted a report from the Director Planning and Building providing information on the Provincial Liquor Policy Review and discussing the possible implications for Burnaby. Staff recommend that any changes to liquor regulations or policies which may affect the nature of licensed restaurants, including definition changes, be considered thoroughly by the Provincial Government with regard to local impact and that local governments be given direct input into the decision making process. The process as designed at present, lacking notice to municipalities of the review as well as direct opportunities for municipal input on what is a major issue with potentially significant local impacts, would seem to be inadequate.

The City Manager recommended:

- 1. THAT Council communicate to the Province its position that any changes to liquor regulations or policies which may affect the nature of licensed restaurants, including definition changes, be considered only after local governments have been given an opportunity for direct input in the process.

2. Burnaby Association for the Mentally Handicapped Infant/Toddler Child Care Services

The City Manager submitted a report from the Director Planning and Building providing information on the proposed closure of the Burnaby Association for the Mentally Handicapped's Infant/Toddler Child Care Programs. The report concludes by advising that the closure of the Burnaby Association for the Mentally Handicapped Programs would be a major concern for Burnaby and that, despite some unique circumstances with BAMH, other operations also face challenges in delivering child care on a financially viable basis. The City Manager recommended:

- 1. THAT the Mayor, on behalf of Council, write to the Minister for Children & Families to request that:
 - a) emergency funding be provided to assist with the Burnaby Association for the Mentally Handicapped's current child care program deficit, on the understanding that the Association will continue to i) operate the programs until at least 2000 March 31, and ii) work with the Province in developing an approach to running the operations on a financially viable basis,
 - b) sufficient funds be allocated through the Public Services Employers' Council to cover the costs of any settlements reached for the Child Care Sector at the Community Social Services Employers' Association bargaining table, and
 - c) a Provincial Child Care Plan be developed to provide increased stability and certainty to the child care sector in BC.
- 2. THAT copies of this report be sent to Burnaby's four MLAs and Jack Styan, Executive Director of the Burnaby Association for the Mentally Handicapped.

3. Bylaw Amendments pertaining to Cemeteries and the Preservation of Trees

> The City Manager submitted a report from the Director Planning and Building responding to Council's direction from the 1998 November 23 Council meeting regarding the Master Plan submission by Forest Lawn and providing Council with recommendations to address the edge conditions and the removal of trees on P4 Cemetery District Zoned Land.

The report concludes that the current regulations are in need of amendment in order to provide an adequate land use separation and landscape buffer between properties zoned P4 Cemetery District and residential properties. In addition, a bylaw is required to protect trees; or alternatively to provide for tree replacement when tree retention is not viable on P4 zoned lands in light of the significant forested areas on these lands which could be removed without any City control or input. Further, the inclusion of the P4 District as a Zoning District upon which comprehensive development zoning may be based is recommended in order to provide the opportunity for a creative approach to the development of cemetery lands, which could reflect the objectives of both the cemetery operator and the City.

The City Manager recommended:

- 1. THAT Council authorize the City Solicitor to amend the Zoning Bylaw to:
 - a) Establish a setback for all uses on lands zoned P4 Cemetery District,
 - b) Require appropriate landscaping within the required setback areas and
 - c) Include the P4 District as a zoning district upon which CD Comprehensive Development District zoning may be based,

as further described in Section 4.1 of this report.

- 2. THAT Council authorize the creation of a bylaw to address the removal of trees on lands zoned P4 District.
- 3. THAT copies of this report be sent to the owners of the four cemeteries located in Burnaby, Mrs. Parvin Chami, Ms. Linda Demers of the Greentree Village Committee, and Mr. Darrin Clarke, 3776 Victory Street, Burnaby, B.C. V5J 1P3.

MOVED BY COUNCILLOR RANKIN: SECONDED BY COUNCILLOR CORRIGAN:

"THAT the recommendations of the City Manager be adopted."

7. NOTICE OF MOTION

Councillor Lawson

Councillor Lawson advised of her intent to introduce the following motion at the 1999 January 25 Council meeting:

"THAT WHEREAS Section 679 of the Municipal Act

- (a) provides a Council with the authority to regulate the carrying on of business in the municipality, to the extent not inconsistent with the intent of that Act or any other, for the purpose of preventing or minimizing nuisances, and
- (b) specifies that a bylaw to regulate business may provide different regulations for different classes of business,

AND WHEREAS Council on behalf of its citizens desires to ensure that the carrying on of operations at gambling establishments does not create a nuisance in the areas immediately adjacent such establishments especially during the nighttime hours,

THEREFORE, BE IT RESOLVED THAT,

1. Staff investigate and report back to Council on the advisability of enacting a bylaw to regulate the hours of operation of any gambling establishments in the City."

Councillor Rankin retired from the Council Chamber at 9:27 p.m. and did not return to the Council meeting.

Councillor Lawson

Councillor Lawson advised of her intent to introduce the following motion at the 1999 January 25 Council meeting:

"**THAT WHEREAS** the Provincial Fire Commissioner has, according to the news media, recently banned the display of children's art-on-paper in the hallways of schools and other similar areas of public assembly; and

WHEREAS there are many more real life threats to children's life and limb than their very proud display of art-on-paper, accompanied by the promotion of their self esteem, in school hallways; and

WHEREAS this alarming attack on the public display of art-on-paper and, presumably, other possibly inflammable materials, will result in unnecessarily adding to the hardships of artists who are at the bottom of the economic totem pole at the best of times;

THEREFORE BE IT RESOLVED THAT:

- 1. Council write to the Provincial Fire Commissioner asking that this patently silly edict be reconsidered as soon as possible, and
- 2. That a copy of this motion be sent to the Minister of Municipal Affairs and to all Burnaby MLA's."

Councillor Johnston

Councillor Johnston advised of his intent to introduce the following motion at the 1999 January 25 Council meeting:

"THAT WHEREAS the motion picture and television production industry has grown into a very significant economic generator producing untold millions of dollars of spinoff benefits in many Canadian cities, including Burnaby;

AND WHEREAS the industry provides employment for large numbers of highly skilled professions and a host of other Canadians in all facets of the production process and its support industries;

AND WHEREAS substantial numbers of Canadian young people are currently enrolled at post-secondary educational institutions receiving training to enter the field;

AND WHEREAS the Federal government at this time is considering steps with respect to Income Taxes levied on non-Canadians working in the film and television industry in Canada that, we are given to understand, are liable to have a devastating effect on the otherwise healthy and profitable Canadian history;

AND WHEREAS in this day of economic uncertainty and declining economic activity in many of the resource-based industrial sectors there is a need to be good stewards of those areas of economic activity that can continue to provide employment and stimulate investment;

THEREFORE BE IT RESOLVED THAT this Council pass a resolution of support for the efforts of the Premier of British Columbia to urge the Federal government to reconsider its position immediately, to determine an alternative method to resolve the taxation issue, and to implement a solution that preserves and enhances this industry without delay, and further that it convey its support to the MLAs and MPs who represent Burnaby and to the FCM and UBCM with a request that they in turn indicate their support for the resolution."

Council also requested that the notice of motion include that a copy of the resolution be forwarded to the Prime Minister of Canada and the Minister of Finance.
