### **PRESENTATION**

Lower Mainland Treaty Advisory Committee Update on Treaty Negotiations in Lower Mainland Presenters: Mr. David Didluck, Councillor Nancy Chiavario

Mr. David Didluck, Executive Director, Lower Mainland Treaty Advisory Committee appeared before Council and introduced Ms. Sheila Beauchemin, Acting Negotiator, B.C. Team South, Ministry of Aboriginal Affairs and Ms. Shannon Kaplun, Project and Communications Coordinator, Lower Mainland Treaty Advisory Committee.

Councillor Rankin retired from the Council Chamber at 7:10 p.m.

Mr. Didluck opened his comments by acknowledging Councillor Jim Young and Mr. Chad Turpin, Deputy City Manager - Corporate Services as representatives on the Lower Mainland Treaty Advisory Committee and thanked them for their input and participation. Mr. Didluck provided Council with an overview of the Committee's work and a summary of current and very pressing issues concerning treaty negotiations in the Lower Mainland. Mr. Didluck advised that the treaty process has six stages and involves the Federal, Provincial and First Nations Governments. Each negotiating table reflects a tri-parti representation and it is important to remember that the Lower Mainland Treaty Advisory Committee is a member of the Provincial Negotiating Team.

Ms. Sheila Beauchemin, Acting Negotiator, B.C. Team South, Ministry of Aboriginal Affairs appeared before Council to discuss the various stages of the negotiation process. Ms. Beauchemin advised that TAC representatives are requested to share ideas on mechanisms for long term relationships, specific issues and suggested solutions and effective public communication. In concluding her comments, Ms. Beauchemin provided Council with a 1-800 telephone number and a web site address should anyone wish further information.

Councillor Rankin returned to the Council Chamber at 7:18 p.m. and took his place at the Council table.

Ms. Shannon Kaplun, Project and Communications Coordinator, Lower Mainland Treaty Advisory Committee appeared before Council to provide an update on the various stages of the negotiation process with respect to Twassassen, Musqueum, Squamish and Tsleil-waututh. Ms. Kaplun advised that the key areas for negotiations involve land, governance, cultural and heritage, capacity building and certainty.

Councillor Corrigan retired from the Council Chamber at 7:31 p.m.

In concluding the presentation, Mr. Didluck advised that treaty negotiations involve a multitude of complex, sensitive and often competing public policy issues. Many of the issues arising from treaty negotiations are within the "business" of local governments. In fact, many are dealt with by municipalities on a daily basis. Mr. Didluck therefore hoped that local governments' direct participation in treaty negotiations will assist in promoting the development of meaningful partnerships between First Nations and local governments and bring creative resolutions to the issues that all communities face.

A) Mr. Vic Blancard, 4630 Highlawn Drive appeared before Council to discuss matters pertaining to slot machines, increased taxation, the GVRD and property assessments.

Councillor Corrigan returned to the Council Chamber at 7:35 p.m. and took his place at the Council table.

B) Mr. Gordon Smith, 3786 Arbor Street, Burnaby appeared before Council to discuss matters pertaining to demolition of the trees on the western edge of Ocean View Cemetery on 1999 March 02. Mr. Smith advised that he would not go into great detail about the devastation brought on by Service Corporation International as he trusted that Council members had either visited the site or seen pictures of it. Mr Smith noted that the area of total devastation was once the home of a wide variety of wild life including coyotes, raccoons, squirrels, birds of all kinds including pigeon hawks, coopers hawks, crows, woodpeckers and blue jays.

Mr. Smith advised that the residents adjacent to Forest Lawn Cemetery and Ocean View Burial Park received correspondence from SCI which suggested that they had previously met with the neighbours and expressed a willingness to work as a team to resolve the issues being faced. Mr. Smith stated that SCI did not meet with any of the neighbours.

The architect's drawings which were available for review at the Planning Department Office clearly showed a significant setback from Joffre and a screen of trees. Therefore the neighbours felt reassured that some of the trees which had been gradually removed over the years would be left. Since the devastation of March 02 and 03, SCI have had a berm of soil built up along the cemetery side of the devastation. It is now virtually invisible from the cemetery side. Further, Mr. Smith indicated that there has been no discernible attempt by the Company to clean up the mess. In concluding his comments, the speaker advised that Section 541 of the Municipal Act gives the City of Burnaby, among other things, the power to "do other things necessary for the safe use of highways". Because there is a park at the corner of Joffre and Rumble Streets which is constantly used by neighbourhood families with young children and, because SCI has characterized its facility as a burial park, Mr. Smith suggested extending the park zone along Joffre Street as far north as Hurst Street. Further, he suggested that the City use its power under Section 541 and Section 545 to "classify and regulate and provide different regulations for different classes of highways". To this end Mr. Smith suggested that a bylaw be passed such that any vehicles, except City service vehicles, a vehicle weight over 3 tonnes, entering or leaving Ocean View Cemetery be required to obtain a City permit before entering the park zone on Joffre Street.

Mr. Smith also suggested that the City immediately adopt a policy of no further construction at the Ocean View Cemetery site until such time as the requirements of Burnaby's setback and tree bylaws have been fulfilled. The City should also adopt, as a bylaw or bylaw amendment, that before any future construction is commenced on the cemetery site all landscaping and screening be in place. Mr. Smith requested the City require an advanced deposit of \$100,000 by SCI to cover any fines levied for bylaw violations.

Arising from consideration of the delegation's presentation, Councillor Volkow was given leave by Council to introduce the following motion:

C) Amarjit and Balinder Johal, 5850 Elgin Place, Burnaby, B.C. appeared before Council accompanied by their architect, Mr. Fred von Drathen to discuss issues pertaining to driveway access to their property at 5850 Elgin Place.

Mr. von Drathen presented a diagram which he felt simplified the cross section through the property and also depicts the original elevations. Mr. von Drathen expressed support for the position taken by Mr. and Mrs. Johal that staff should have informed the Johals of the pending cul-de-sac plans when they initially came to City hall to have their building plans approved. Mr. von Drathen suggested that the Johal family has been failed by the system and the easiest way to remedy the wrong would be to leave the cul-de-sac at its existing elevation thereby permitting the Johals' to build their garage at ground floor level with access to be taken from the cul-de-sac. Mr. von Drathen suggested that this would be a more economical solution for Mr. and Mrs. Johal and would provide convenient on-site parking on a very difficult lot.

#### 6. **NEW BUSINESS**

#### Councillor Rankin

Councillor Rankin introduced discussion regarding a document recently released by the Provincial Government entitled "Transformation Solutions" which outlines proposed changes in the liquor policy. One of the main aspects in the document that causes concern is in regard to existing hotel pubs, lounges, neighbourhood pubs, marine pubs and cabarets. Councillor Rankin indicated that the document proposes to enable these facilities to increase capacities to the building occupancy limit with no local government input.

### **Councillor Lawson**

Councillor Lawson introduced a discussion regarding the recent announcement from Light Rapid Transit regarding a change in timing and priorities pertaining to the proposed rapid transit line through Burnaby. Councillor Lawson suggested referring the matter to staff to report on the status of this situation.

#### Councillor Rankin

Councillor Rankin advised that, as a result of attending recent meetings regarding Light Rapid Transit, it has been learned that Burnaby is now being pressured to accept proposed changes which will see the New Westminster/Coquitlam link as a first priority as opposed to the original priority of the Broadway/Lougheed line. Councillor Rankin advised that if the proposed move is adopted, it would be a major change in regional policy.

Councillor Rankin indicated that the reason for the proposed change in policy is the thought that a subsequent government will cancel the uncompleted portions of this project and the only part of the project that will be built before this could happen would be the New Westminster to Coquitlam line and Burnaby would be completely cut out of the picture, thus the project cost would be significantly lower. It is also thought that Burnaby could be well serviced by an enhanced bus service and therefore there is no need to build the Broadway/Lougheed link at this time.

Councillor Rankin reminded Council that Burnaby's buy-in to the Liveable Region Strategy and Growth Objectives were contingent upon the Broadway/Lougheed project being a high priority. Councillor Rankin clearly stated that Burnaby is the community that is most ready and receptive, both in land use planning and the transportation corridor to accept Skytrain.

## MOVED BY COUNCILLOR LAWSON: SECONDED BY COUNCILLOR EVANS:

"THAT staff prepare a report bringing Council up-to-date on the recent changes proposed for Light Rapid Transit."

#### **Councillor Lawson**

Councillor Lawson requested information regarding the possibility of the Pacific National Exhibition relocating to an industrial zoned property in the Big Bend Area.
