RECOMMENDATION:

REPORT

The British Columbia Teachers' Federation will be hosting the 1999 General Meeting of the Canadian Teachers' Federation in Vancouver from July 12 - 16. This meeting will draw together over 225 educators representing all the provinces and territories. The B.C. Teachers' Federation submission requested a grant to assist with the cost of hosting an evening function at Burnaby Village Museum. This function will be the main social activity of the conference.

#10/99 Slovenian Society of Vancouver

RECOMMENDATION:

THAT this grant application be denied.

REPORT

An application was received from the Slovenian Society of Vancouver requesting a grant in the amount of their property tax bill to assist with the cost of the organization's cultural activities. The non-profit Society supports the Slovenian Folklore Dance Group. One of the ways the Society seeks to foster and promote a greater understanding of cultural traditions and philosophy is through dance. Multicultural events the Society has participated in include Burnaby Discovery Days, Kitsilano Showboat and Dragonboat Festival.

The Society has owned and operated a hall in Burnaby since 1972. The hall is used for social and cultural events and is available for use by others. Two world champion Slovenian choirs have performed at the hall. Both of the concerts were very well received by people from all over the lower mainland who enjoy chamber and choral music.

#15/99 Burnaby Christmas Bureau

RECOMMENDATION:

1. THAT a grant in the amount of \$1,000 be awarded to the Burnaby Christmas Bureau for its 1998 Christmas Campaign.

REPORT

An application was received requesting financial assistance for the 1998 Christmas Campaign. The Burnaby Christmas Bureau provides low income Burnaby families with food gift certificates and new toys for their children. In 1997, the Burnaby Christmas Bureau distributed \$101,700 in food gift certificates which provided 4,493 people with a Christmas meal. In addition, 7,938 new toys were provided for children to enjoy.

#16/99 Burnaby Meals on Wheels

RECOMMENDATION:

1. THAT a grant in the amount of \$7,000 be awarded to Burnaby Meals on Wheels for 1999.

REPORT

An application was received requesting a grant toward the cost of providing and delivering meals to Burnaby shut-ins.

Burnaby Meals on Wheels is in its 31st year of operation. In 1998, over 18,000 meals were delivered to Burnaby shut-ins. The grant money will be used to reimburse volunteer drivers for gas and to replenish client delivery boxes.

REPORT

An application was received requesting a grant to assist with transportation of Burnaby seniors to medical appointments. This service is operated by a dedicated group of volunteers who drive seniors to and from their appointments. The drivers also help the seniors into and out of the doctor's office or hospital. This service affirms a commitment to a high quality of life for older citizens and allows them to maintain an independent lifestyle for as long as possible.

An application was received requesting a grant to support services provided by Big Sisters of B.C. Lower Mainland to the children and families of Burnaby.

Big Sisters is committed to enhancing the self esteem and well being of children and youths by fostering and encouraging supportive friendships with women volunteers who act as role models. The program helps children and youths realize their individual potential and grow up to be confident, capable adults.
