Staff advise that the development of a revised master plan for Barnet Marine Park will require extensive and thorough analysis and design phases, including comprehensive water and land assessments, environmental studies, detailed engineering plans and landscape design, and construction specifications. Until approval by the

Burrard Environmental Review Committee is granted, no construction can take place, and when it does, it must fall within the Department of Fisheries and Oceans allowable timing window for construction which is based on the period of least environmental impact to aquatic habitat/resources.

Staff conclude by indicating that sufficient capital reserves are available and the project is included under the 1999 major parks component of the 1999-2003 Provisional Capital Budget.

AND WHEREAS the News Release recently issued by the Ministry of Employment and Investment with reference to the white paper and draft gaming control legislation indicates that it is being recommended that the Provincial Government, rather than local government, have sole jurisdiction over the types of gaming activities in existing casino operations,

AND WHEREAS the provincial government has invited public comment on the matter before mid-March, whereby this obvious disparity can be addressed,

THEREFORE BE IT RESOLVED THAT this Council urge the Province of B.C. to ensure that any changes in legislation respect and preserve the right of local government to regulate the location of casinos and the various forms of gaming activities they contain as a land use matter in municipalities, and further that a copy of this resolution be forwarded to the Union of B.C. Municipalities and to Burnaby's four Members of the Legislative Assembly."
