The Committee considered it desirable for the continuity of the widened pavement to be expanded, particularly between MacPherson Avenue and Gilley Avenue where, it was understood, that pavement rehabilitation was not imminent.

Accordingly, the Committee recommends that Council endorse the concept of "retrofitting" pavement widening in this section and that the cost of doing so be appropriately budgeted.
