- A) **Ms. Jean Piovesan**, 5538 Clinton Street, Burnaby appeared before Council in support of the proposed R12 area rezoning for Clinton Street. Ms. Piovesan shared supporting demographic information which she had obtained from Statistics Canada, B.C. Assessment Authority, the Greater Vancouver Regional District and Burnaby's Building Department.

*Councillor Corrigan arrived at the Council meeting at 7:06 p.m. and took his place at the Council table.*

*Councillor Redman arrived at the Council meeting at 7:07 p.m. and took her place at the Council table.*

The speaker addressed matters concerning front to back duplex development, maintaining character in the neighbourhood, upgrades through local improvement projects, perceived loss of green space and the fear of some residents that R12 zoning will create a "slum" community.

In concluding her comments, Ms. Piovesan stressed that she did not wish to divide the neighbourhood and could not be responsible for the changes that have taken place in the area in the past. Ms. Piovesan recognized that nobody likes change but, she acknowledged that change is inevitable and, if handled properly, can be accomplished in an orderly fashion.

The speaker submitted a petition to the City Clerk containing the signatures of 97 residents in support of the proposed R12 area rezoning.

- B) Mr. Xuhui Hu**, 5476 Clinton Street, Burnaby appeared before Council opposing the proposed R12 area rezoning for Clinton Street. Mr. Hu advised that he was shocked when he viewed the plans for the neighbourhood and found the proposal to be totally unacceptable. Mr. Hu suggested that R12 zoning will increase traffic and parking problems in the neighbourhood and destroy the peace and quiet which area residents currently enjoy. Mr. Hu urged Council to turn down the R12 area rezoning proposal.

**Ms. Baljinder Narang**, 6050 Clinton Street, Burnaby appeared before Council in opposition to the R12 area rezoning proposal for Clinton Street. Ms. Narang contended that the survey sent by the City to the area residents resulted in only 39 percent of residents in support of the application. Residents were assured that support for an R12 area rezoning must be overwhelming before Council will approve the proposal. Further, the speaker reminded Council that the Royal Oak Advisory Committee recognized the subject area as a residential neighbourhood and was concerned that small lot subdivision would lead to the introduction of illegal suites. In concluding her comments, Ms. Narang stressed to Council that approval of the subject R12 rezoning would be precedent setting for the rest of the City and was concerned that the threat of the rezoning is causing instability in the community.

**Mr. Bryce Waters**, 5460 Clinton Street, Burnaby appeared before Council expressing his opposition to the R12 area rezoning proposal. Mr. Waters contended that side-by-side or back-to-front duplexes on small lots would not be very attractive and was at a loss as to why anyone would support such a proposal. The speaker suggested that R12 zoning will devastate the neighbourhood because any new development on smaller lots will not allow enough room for trees, shrubs and flowers.

- C) **Ms. Alexis Hodgkins**, 8639 Armstrong Avenue, Burnaby and Ms. Colleen Meade, 7676 Endersby Street, Burnaby appeared before Council requesting Council to vote "no" for the proposed field lights at the new sports fields at Cariboo Oval. Ms. Hodgkins advised that she had invited Council members into her home over the past weekend so they would see first hand what the situation was and then be able to vote in a more informed manner and with a clear conscience.

Ms. Hodgkins suggested that the proposal to have field lights turned off on Fridays, Saturdays and Sundays at 6:00 p.m. was not a generous compromise as these days are already recognized as low use periods. Having field lights on until 10:00 p.m. on week nights was totally unacceptable in a neighbourhood of working families.

In concluding her presentation, Ms. Hodgkins advised that "no lights" is the demand of the neighbourhood and requested Council to treat the residents with the same compassion shown to the Greentree residents when they deal with a large corporation intruding on a quiet neighbourhood.

Staff will schedule a classified vehicle count midway between Kingsway and 15th Street to determine vehicle speeds. The data would be forwarded to the Police for consideration of speed enforcement as required. The gist of this note will be conveyed to Mr. Hutton.

**6. NEW BUSINESS**

**Councillor Begin**

Councillor Begin announced, with regret, the passing of former School Trustee Audrey Kenney.

His Worship, Mayor Drummond advised that his office, on behalf of Council, would send flowers and condolences to the Kenney family.

**Councillor Volkow**

Councillor Volkow advised that he was in receipt of correspondence from the Burnaby Fire Fighters Local 323 advising that the Workers' Compensation Board is currently considering an amendment to the Occupational Disease section of the Workers' Compensation Act Regulations, more specifically Item 5 of Schedule B, known familiarly as the Heart Presumption for Fire Fighters. The correspondence advised that, if the Act is amended, the Board would be permitted to deny claims on heart injury or disease including heart attack, cardiac arrest or arrhythmia, disease of the pericardium, heart muscle or coronary arteries where the worker is employed as a fire fighter, based on medical evidence that shows congenital or hereditary predisposition and/or lifestyle causes (smoking, obesity, etc.)

Councillor Volkow advised that the Burnaby Fire Fighters Local 323 rejects this proposed amendment to the Act recognizing that there is not any other worker group subjected to the smoke and accompanying toxins to which fire fighters are, not to mention the sudden surges of adrenalin and stress when suddenly called to action. Burnaby Fire Fighters contend that there is, in fact, strong evidence of an increased risk of death overall from heart injury and disease among fire fighters.
