His Worship, Mayor Drummond advised that Local Heroes are individuals who have made an important contribution to community well being in Burnaby over several years.

Each year since 1997, the Community Issues & Social Planning Committee has recommended a list of Local Heroes to be considered for recognition. Including this evening's nominees, Mayor Drummond acknowledged that 30 Local Heroes have been recognized since the program's inception.

Mayor Drummond then called upon Councillor Johnston, Chair of the Community Issues & Social Planning Committee, to join him in making the presentations to Burnaby's 2000 Local Heroes.

Councillor Johnston then introduced the following Local Heros:

Mark Angelo: Mark currently serves as Program Head of BCIT's Fish, Wildlife, and Recreation Program. He is a renowned expert on rivers who has spearheaded numerous environmental studies and stewardship activities in Burnaby, BC, and Canada. For his achievements, Mark has been recognized with the Ten Year National River Conservation Award; the

City of Burnaby Environment Award in Communication; BC Ministry of Environment's Environmental Award; and the Order of BC. The Board Member profile for the BC Heritage Rivers System describes Mark as being "at the heart of river conservation and stewardship for the past 20 years in this province" and credits him with providing "the kind of inspired leadership that has drawn a considerable following."

- Lillian Chalmers: Lillian has volunteered in several capacities in Burnaby for nearly 40 years. Friends describe her as "one who models selfless giving giving without any expectation of anything in return." She has served on the Boards of the United Way and Information & Community Services. She has also volunteered with seniors at the Fair Haven Residence; helped various groups through outreach programs at South Burnaby United Church; worked with women who have escaped abusive relationships through Marguerite Dixon House; and offered her services to recent refugees who need assistance with the process of settling into a new life in Burnaby. Lillian is a charter member of the strata council in her housing development (Mission Woods) and is described as a "wonderful neighbour who contributes to making Mission Woods a great place to live."
- Glenice English: Glenice is a long time Burnaby resident who has worked in the child care field for twenty-five years the past twenty with SFU Child Care Society. She is scheduled to retire this December. Parents and colleagues at SFU single out Glenice both for her strong and compassionate work with children, and for the training and support she has provided parents in improving their parenting skills. As a testament to her lasting influence and impact, many families continue to remain in touch with Glenice long after they have left her child care program, often inviting her to special family functions, weddings, and graduations.
- Philip Henderson: Phil has a long, distinguished, and varied career as a volunteer in Burnaby. He currently serves as Treasurer with the Burnaby Lougheed Lions Club and coordinates the Club's annual Skate-a-Thon event. He played a key role in the planning and development of the St. Margaret's of Scotland Abbeyfield Housing complex and is actively involved in management of four non-profit housing developments in the city. His other volunteer contributions include serving as President of St. Leonard's Youth and Family Services and official auditor for the Royal Area Girl Guides; driving for Meals on Wheels; and helping with numerous activities through St. Margaret's of Scotland Anglican Church. Last but not least, Phil currently serves on the City's Community Issues & Social Planning Committee and Advisory Planning Commission.

- Grace Jo: Grace Jo has been a volunteer with numerous Burnaby organizations over the years. Her past and present volunteer efforts include volunteering with the blood pressure clinic of the Bonsor Seniors Health Alert Program; teaching fitness to seniors at Chaffey Lane Apartments; volunteering with the RCMP Victim Assistance Program; serving as guest speaker at workshops concerning abuse of seniors; helping low income seniors in completing their income tax returns; serving on the Community Policing Committee; and serving on the Board and raising funds for Douglas College. For her significant contributions to the community, Grace Jo has earned the nickname "Amazing Grace."
- Vorking with the City's Citizen Support Services program, she has helped with hearing screening clinics, breast feeding clinics, the Flying Grandmother program, and seniors flu clinics. She has also served on the Burnaby Library Board and Burnaby Centennial Committee and contributed to such groups as the Burnaby Volunteer Bureau, Burnaby Hospital, and Burnaby Village Museum. Her friends note that Les Lee "has the . . . stuff that volunteers are made of . . . (being) energetic, tireless and highly dedicated and loyal."
- Society for the past 2 ½ years. While the Hospice Society considers all its volunteers as their "very own heroes," it pinpoints Barbara as a standout. Since beginning work with the Society in early 1998, Barbara has helped seven clients through the difficult and trying process of dealing with death and dying. She has followed her clients from their homes, to the hospital, and sometimes to Continuing Care facilities. According to her nomination form, Barbara is "one of those rare volunteers who will do her best for a cause that they truly believe in and . . . (through her) dedication to her clients and the Hospice Society, she stands out as going 'above and beyond' the call of duty."
- Tony Mauro: Tony is the owner of Anton's Restaurant. Along with his staff, he has made a significant contribution to Burnaby families in recent years. For example, for the past three years, along with other managers and staff from his restaurant, he has donated and prepared free meals for low income families at Christmas. In addition to the food, he and his staff have bought and wrapped presents for each child in attendance. In 1999, they served Christmas meals to a total of 350 people. The people submitting the nomination praised Tony and his staff for the generosity and compassion they have shown towards low income Burnaby families and the community.

Councillor Redman arrived at the Council meeting at 7:14 p.m. and took her place at the Council table.

Councillor Johnston noted that Tony Mauro was unable to attend the Council meeting due to illness.

- Doreen Player: Doreen is a long time resident of north Burnaby who has contributed to her community in numerous ways. She is an active member of the Burnaby Soroptimist Club, a service club of business and professional women which provides help to such groups as battered women, long term caregivers, and Queen's Park Hospital. Doreen is probably best known for her work with seniors through the Confederation Community Centre for the Retired. She is passionate about fitness. Leading by example, she is credited with encouraging and supporting seniors to maintain an active and healthy lifestyle as they age. She has also been an inspiration to numerous students in SFU's Kinesiology program, supervising an estimated 60 practicum students from the program over the years. In the words of the person nominating her, "the only consistency in Doreen's volunteer endeavours is her tireless and giving nature."
- Joyce Rosteron: Joyce has been a committed volunteer with Second Street Community School since 1988. She has coordinated the annual Halloween fireworks displays, served as secretary of the Community Council, and "rolled up her sleeves" at numerous community events. Perhaps her crowning achievement has been her leadership in the "greening" of the Second Street Community School, through development of a garden in the school's playground area. Students of Second Street Community School were recognized last year with the City's Youth Environmental Award for their work on the garden. Joyce's nomination form states "it is time to (also) recognize our Local Hero, Joyce . . . for her initiative in this tremendous project."
- Carol Roycroft: Carol experienced a serious stroke ten years ago. In spite of serious physical limitations, the person nominating Carol states that she "remains upbeat, cheerful, and extremely busy improving the lives of others." For several years, Carol has worked as the president, and often as acting coordinator, of the Burnaby North Stroke Recovery Club. She has also served on the Board of the Burnaby South Stroke Recovery Club and publishes a newsletter for stroke recovery patients. Her nominator says: "she is my hero."

Mayor Drummond and Councillor Johnston concluded the presentations by congratulating the Local Heroes for their tremendous contribution to community well being over the years.

Councillor Johnston retired from the Council Chamber at 7:31 p.m.

A) Jim McEwan, Poppy Chairperson for The Royal Canadian Legion Branch #83 appeared before Council, accompanied by **Brian Simpson**, Poppy Chairperson for Branch #148 to kick off the 2000 Poppy Campaign.

Mr. Brian Simpson advised that Branch #148 donated \$20,000 through its 1999/2000 Poppy campaign for a variety of charitable purposes in the community. Mr. Simpson thanked Council for its support.

Mr. Jim McEwan advised that the thrust of Branch #83's Poppy Campaign is to focus on school programs and distribute materials to schools throughout Canada for competitions in essays, poetry and art work, all relating to Remembrance Day. Mr. McEwan advised that he was very proud this evening to introduce Miss Ruth Legg from Burnaby South High School, the national winner of the competition for Prose regarding Remembrance Day, accompanied by her Teacher, Mr. John Terpening who was in attendance to represent Burnaby South Secondary School. Mr. McEwan requested His Worship, Mayor Drummond's assistance in making an official presentation to Miss Ruth Legg and to Burnaby South School.

Councillors Corrigan and Johnston returned to the Council Chamber at 7:37 p.m. and took their places at the Council table.

B) James McConnell, Head of School, Stratford Hall, 3075 Slocan Street, Vancouver appeared before Council to advise of his goal to establish an independent university-preparatory school to serve the Burnaby area. Mr. McConnell advised that the School had reached its first milestone in September, 2000 by opening its doors to 60 students, many of which are Burnaby residents. The school is temporarily located in east Vancouver, however, since early efforts to find a site in Burnaby were fruitless.

The delegation advised that the Founders of the school have expressed their desire to locate within the boundaries of Burnaby and, because most of the families reside in Burnaby it makes sense to renew their quest for site in Burnaby. Mr. McConnell suggested that a permanent site would benefit the City because it would provide a much-needed educational choice for parents and also brings families into Burnaby from adjoining cities.

In concluding his comments, Mr. McConnell welcomed the opportunity to meet with Planning staff for the purpose of elaborating on the plans and work closely with the City in the search for an appropriate site. Further, the delegation invited members of Council to visit the current school site and tour the facilities.

C) Ms. Teresa Watts, Director of System Design, Rapid Transit Project 2000 Limited appeared before Council accompanied by Whitney Birch, Transportation Planner to follow up on the recent RTP 2000 report entitled "The Millennium Line Fare Technology Safety and Security Study" which was presented to the TransLink Board of Directors on October 3rd.

By way of introduction, Ms. Watts advised that, since 1986, SkyTrain has been a transit success in the Lower Mainland and has performed well relative to other rail transit systems around the world. The 29 kilometer line has undergone three expansions since opening day and now carries more than 40 million passengers per year. Ms. Watts suggested that, despite this success, improvements can be made to increase SkyTrain's popularity and attract additional ridership.

To that end, the delegation advised that years of market research and public consultation reveal that particular focus is needed on improving passenger safety and security. The research shows that public concern regarding safety and security and fare evasion keeps people from using SkyTrain, makes existing riders feel uncomfortable while using the system and reduces SkyTrain's appeal as a mode of travel. RTP 2000 has undertaken extensive study to develop strategies that will address public concern about safety and security associated with using SkyTrain.

The speaker advised that B.C.'s Attorney General conducted a review of law enforcement options on the SkyTrain system and, as a result, recommended the establishment of a designated police force consisting of officers from local departments. This force will have the necessary law enforcement powers to effectively police the SkyTrain system and deal with drug-related and other crimes. The Attorney General will work with local municipalities and TransLink to address their suggestions and finalize the plan.

With regard to Millennium Line fare compliance options, Ms. Watts advised that RTP 2000 engaged a consulting firm to identify fare compliance and enforcement options from other transit systems and to conduct an economic evaluation of a selection of options for the Millennium Line. Working with TransLink, three options were identified for evaluation, including:

- Base Case continue with existing Proof of Payment system and current staffing levels on both the Millennium Line and existing Expo Line
- Full Proof of Payment staffing increases (50% increase) to achieve fare compliance levels equal to the gating option
- Full Gating adding gates and staff at all stations.

The results of the analysis show that the Full Gating option provides the most benefits at the least cost. In particular, Ms. Watts advised that Full Gating is anticipated to enhance passenger safety and security, attract additional ridership and reduce fare evasion on the system.

In summary, the delegation advised that market research and public consultation demonstrate a lack of public confidence in the current proof of payment system. The public supports more and more visible staff and a Full Gating system. Changes to address these issues will require additional funds.

address municipality-specific issues. The Committee further advised, however, that a number of issues remain unresolved in the revised regulations, such as a critical need for co-ordination between federal and provincial regulations, the matter of a liability protection clause and details regarding Environmental Review Committees, dispute resolution processes and watershed management approaches.

The Environment and Waste Management Committee recommended:

1. North Road SkyTrain Alignment

The City Manager submitted a report from the Director Planning and Building seeking Council approval of a recommended position concerning the alignment of the proposed SkyTrain extension from the Lougheed Town Centre Station along the North Road Corridor to Clark Road.

Staff report that the process associated with the selection of an agreed to alignment for SkyTrain up North Road has been lengthy and somewhat circuitous. Nevertheless, from the City of Burnaby's perspective, the issue is a simple one. In the same way that the City of Coquitlam has a fundamental objection to an "East Side Option" given its obvious direct impacts on its existing and future flanking land uses, Burnaby views a "West"

Side Option" as being equally repugnant. A west side alternative would directly impact the City's ability to provide high density residential consistent with the adopted Lougheed Town Centre Plan and the Livable Region Strategic Plan and would also impact the future redevelopment of the Sullivan Heights residential area. As such, a "West Side Option" cannot in any way be supported or be assisted by the City.

The City Manager recommended:

- 1. THAT Council endorse the Centre Median Option as the preferred alternative related to the North Road SkyTrain corridor subject to the specific assumptions as outlined in Section 4.3 of this report.
- 2. THAT Council reject the West Side Option and advise the TransLink Board that this is an unacceptable alternative and will not receive any support or co-operation from the City of Burnaby.
- 3. THAT the TransLink Board be advised that if the Enhanced Median Option is to be the selected alternative then Council would insist that the terms as contained in Section 7.0 of this report be concurrently adopted.
- 4. THAT a copy of this report be forwarded to the Chair, TransLink Board; the City of Coquitlam; President, Rapid Transit Project 2000 and Burnaby MLA's.

MOVED BY COUNCILLOR JOHNSTON: SECONDED BY COUNCILLOR EVANS:

2. Issues Surrounding Cascade Residence Replacement

The City Manager submitted a report from the Director Planning and Building identifying and assessing issues regarding the Cascade Residence replacement process.

Staff note that a key conclusion is that, while concerns exist, the proposed replacement of the Cascade Residence is logical and is part of a broader package of changes being planned for the Health Region. The existing Cascade facility is old and institutional in character and would be difficult and expensive to bring up to current multi-level care standards. Provided

that the concerns raised in the report can be addressed, it is believed that a new replacement facility has the potential of offering a quality home-like environment for seniors in care.

The City Manager recommended:

- 1. THAT Council inform the Simon Fraser Health Region that the City's position regarding the Cascade Residence replacement process will be contingent upon receiving a satisfactory response to the following:
 - a) confirmation of the Health Region's commitment to keeping Cascade Residence operational until the replacement facility is built, and providing assurances that the transfer of residents from Cascade to other facilities will occur smoothly, with minimal disruption to the residents or their families
 - b) assurance that, if demand warrants, the multi-level care beds in the Cascade replacement facility and future multi-level care development will be able to accommodate an increased proportion of Extended Care clients than originally envisioned
 - c) commitment to preparing an implementation plan which offers details about the strategies and resource requirements for developing necessary facility beds and other community-based housing and support services in Burnaby and the Health region over the next 5 10 years
 - d) confirmation that the assisted living units will be affordable to residents, through provision of additional details regarding the range of services to be covered by the residents' rents, the types of additional services that residents may be expected to cover, and the estimated costs of those additional services
 - e) provision of a detailed explanation of the mechanisms that will be used to monitor and ensure the quality of care and services offered through the assisted living units
 - f) provision of assurances that, if the operator of the Cascade replacement facility subsequently claims that the Health Region's operating funds are insufficient, appropriate mechanisms will be in place to review and address the matter and that the quality of care to residents will not, at any time, be compromised
 - g) agreement to treat the Cascade replacement as a "pilot" for the P3 model and committing to formally evaluate its relative effectiveness before using it for future care facility development in Burnaby.

- 2. THAT the Mayor, on behalf of Council, also inform the Chair of the SFHR of the City's willingness to:
 - work with the Health Region, as necessary and appropriate, with the planning and development of Continuing Care services for Burnaby residents
 - b) join the Health Region, as requested, in advocating to senior governments for necessary funding and resources for the local Continuing Care system, including Provincial capital funding for future care facility developments in the city.
- 3. THAT the Mayor, on behalf of Council, write to request the Provincial Ministries of Health and Finance to collaborate on a review of the P3 model, based on the experience in BC and elsewhere, with the goal of ensuring that, if the model continues to be used, sufficient safeguards are in place for ensuring that the integrity of the publicly-funded Continuing Care system is maintained.

3. School Site Acquisition Charge

The City Manager submitted a report from the Director Planning and Building discussing a new School Site Acquisition Charge that has been determined by the Board of School Trustees of School District 41, Burnaby.

Staff advise that, as required by the Education Statutes Amendment Act, the School Board has passed a resolution proposing eligible school sites for the purpose of collecting the new School Site Acquisition Charge. The School Board has estimated it will cost approximately \$61,910,000 to acquire new school sites in the Brentwood Town Centre, Alpha area, Edmonds Town Centre and Burnaby North area over the next ten years. Based on its calculations, the School Board estimates the School Site Acquisition Charge will range from \$600 and \$1,000 per unit depending on the density of the housing units being developed.

Staff recommend that Council approve the School Board's resolution for 2000 concerning the new School Site Acquisition Charge for Burnaby. At the same time, however, it would be appropriate for Council to request the Minister of Education to amend the appropriate legislation to give municipalities and school districts the power to implement SSAC at their discretion. This would be consistent with the direction contained within Council's UBCM resolution.

The City Manager recommended:
