# B) Traffic and Transportation Committee (Traffic Safety Division) Re: Parking at Burnaby Hospital

The Traffic and Transportation Committee (Traffic Safety Division) submitted a report prepared in response to a presentation regarding parking issues around Burnaby Hospital. At the regular Council meeting held on 1999 November 08, Council received a presentation expressing concerns that there are not enough parking spaces available in the Burnaby Hospital parking lot for staff members. The Committee advises that, in Burnaby, hospital employees have subsidized parking available at less expensive rates than the general public and further this rate is lower than other hospitals charge in the Lower Mainland. Free parking at metered spaces is available after 6 p.m. on weekdays and is free for 24 hours on weekends.

#### C) Traffic and Transportation Committee (Traffic Safety Division) Re: Canada Way Sumner Intersection -Follow Up

The Traffic and Transportation Committee (Traffic Safety Division) submitted a report prepared in response to concerns raised regarding the proposed left turn restriction from Sumner onto Canada Way.

The proposed left turn ban from Sumner to Canada Way would result in a diversion of traffic via Manor and Gilmore. This proposed diversion has met with opposition from area business residents because of perceived safety concerns associated with the vertical alignment of Gilmore immediately north of Manor where it overpasses the freeway.

As a result, the Committee is proposing to proceed with a traffic signal at Gilmore Avenue and Manor Street to address these concerns before proceeding with the intersection improvements at Sumner and Canada Way.

The Traffic and Transportation Committee (Traffic Safety Division) recommended:

- 1. THAT Council approve funding of \$100,000 for the construction of full traffic signal at the intersection of Gilmore and Manor.
- 2. THAT a copy of this report be sent to those who have corresponded on this issue as a result of the consultation process.

#### 1. Proposed Gypsy Moth Eradication Program

The City Manager submitted a report from the Director Engineering prepared in response to Council's request for a report on the proposed Gypsy Moth eradication program, particularly relating to the ingredients of the pesticide Foray 48B and the public notification process.

Staff advise the product label indicates that 2.1% of the product is Bacillus thuringiensis var. kurstaki (Btk) and the remaining 97.9% is listed as "inert ingredients".

The B.C. Ministry of Forests is planning an Open House on 2000 January 20 from 7:30 p.m. to 9:30 p.m. at the Bill Copeland Sports Centre in order to provide further information to residents and businesses in the treatment area and the buffer zone.

Members of the public who are at risk with respiratory concerns may use a toll free telephone number available for public information. In addition, those residents who register with the ministry will be provided with a minimum of 24 hours notice before spray programs take place. The City Manager recommended:

1. THAT this report be received for information purposes.

  - Re: Space in Future Major Mixed use developments in Metrotown for visual and/or Performing Arts

**WHEREAS** the City of Burnaby is desirous of promoting a balanced and complete community, that provides a wide range of opportunities and facilities to enrich the lives of its citizens and those who work in Burnaby, and

**WHEREAS** the cultural life of our community can be enhanced through the provision of attractive, conveniently accessible facilities for the display of visual arts and the accommodation of the performing arts, and

WHEREAS the City has in the past been successful in achieving significant space and facility contributions in conjunction with new major mixed use development initiatives, particularly within Burnaby's town centres, that have provided public benefits in various forms including meeting rooms, information kiosks, child care facilities, community-use space for non-profit organizations, and community police station space but to date have not included cultural facilities, and

**WHEREAS** there may be an opportunity to utilize a variety of potential mechanisms to acquire space and/or facilities in such new developments in the future, including voluntary contribution, application of Burnaby's community amenity density bonusing provisions, or potentially private or corporate donations in accordance with provisions made available in conjunction with Revenue Canada, and

**WHEREAS** there is a manifest interest in creating additional and new opportunities for further public access to the visual and performing arts at locations that are easily accessible to the widest possible range of Burnaby families and persons working in Burnaby, and

**WHEREAS** the Metrotown area is not only Burnaby's primary town centre, easily accessible by SkyTrain and public transit, but is also a regional town centre and a major tourist destination, and

**WHEREAS** the accomplishment of significant spaces and facilities for public use in new developments is expected to be necessarily complex and a substantial undertaking in terms of the magnitude of the spaces and values involved, beyond the scope of Burnaby's experience to date,

**THEREFORE BE IT RESOLVED** that staff be requested to examine and report back to Council on the feasibility and desirability of acquiring space in future major mixed-use developments in the Metrotown Town Centre to provide facilities for the City's use to accommodate the visual and/or performing arts, including an analysis of the mechanisms that are practicably available for securing such, including voluntary contribution, density bonusing, and private or corporate donation within the regulations applied by Revenue Canada."

**WHEREAS** Provincial gaming (casino) income has been intended to be used for Provincial government, casino owners and charities, non-profit and other community groups, and

WHEREAS Provincial gaming funds now include municipalities, and

**WHEREAS** the municipal share of these funds is 10% of net proceeds from casinos within their boundaries and Burnaby's anticipated share for the year 2000 is estimated at a minimum of \$2.8 to 4 million, and

**WHEREAS** there is no guarantee that these funds will continue to be allocated to charities, non-profit, and other groups and municipalities in future years, and

WHEREAS the gaming funds are not included in the operating budget,

#### THEREFORE BE IT RESOLVED THAT:

- 1. Burnaby City Council allocate on million dollars of the Provincial gaming funds from the first quarter to a charities, non-profit and other community groups non-statutory reserve fund where only the interest could be used each year, and
- 2. These funds be in addition to the current donations and grants budget, and

3. Staff be asked to formulate terms of reference for approval by Council on the yearly allocation of funds so that the monies would be used in the most efficient and effective way."
