PURPOSE:

REPORT

1.0 BACKGROUND

At its regular meeting of 2000 May 15, Council pledged their participation in the first Council-to-Council Commuter Challenge. The annual Commuter Challenge is a good-natured but spirited competition between Canadian Cities for the distinction of having the country's healthiest commuters. A "healthy" commuter is one who leaves their automobile at home when they travel to their place of work or study.

This year the National Commuter Challenge was held on the Wednesday, 2000 June 07 of Environment Week. Environment Week in turn was held on the first week of June and this year ran from 2000 June 05 to 2000 June 10. However, the day of the National Commuter Challenge conflicted with the Federation of Canadian Municipalities Conference being held this year in London Ontario. This provided an excellent opportunity for the Council-to-Council event to be held as an advance event on 2000 May 30 to increase awareness of the National Commuter Challenge event here in the Lower Mainland.

2.0 AWARDS

2.1 "Walk The Talk" Leadership Award

Better Environmentally Sound Transportation (BEST) has presented their "Walk the Talk" Leadership Award to Council for their role in the 2000 Council-to-Council Commuter Challenge. There is a certificate and one "power bar" (energy bar) for the Mayor and one for each member of Council. Each "power bar" has a label describing the nature of the "Walk the Talk" Leadership Award. There is also one of the highly recognizable "One Less Car" stickers attached to the back of each "power bar" signifying the sustainable transportation theme of the annual Commuter Challenge.

It should be noted that Council achieved 100% participation in the Council-to-Council event.

2.2 First Place Participation Award (351-999 employees category)

This year was the first year that the City of Burnaby placed first in its representative size category (351-999 employees - for the City Hall complex) with 86% participation. In recognition of this achievement, BEST has awarded the City of Burnaby the *Commuter Challenge Award 2000*. This result was also acknowledged in the ad contained in *Attachment A* which ran in the 2000 June 14 edition of the Vancouver Sun and the 2000 June 20 edition of Business in Vancouver.

3.0 CONCLUSION

The Annual Commuter Challenge event organized by Better Environmentally Sound Transportation (BEST) is a good-natured but spirited event designed to increase awareness of the impact our commuting habits have on the environment. This year Council has been recognized for heartily participating in the Council-to-Council challenge held on 2000 May 30 with Vancouver City Council. The "Walk the Talk" Leadership Award presented to Council and the participation award received by the City of Burnaby demonstrate commitment on the part of both Council and staff to the annual Commuter Challenge event.
