In concluding his presentation, Mr. Moysiuk briefly discussed the use of pyrotechnics and their negative impact on the environment and the recent incidents at the Chevron Refinery. Mr. Moysiuk urged Council to take a hard line and force Chevron to take the necessary steps to ensure these types of incidents no longer occur.

The Director Engineering explained that water is chlorinated, with back-up systems in place in the event of a failure and that there is secondary re-chlorination throughout the system. Further, an ongoing process of monitoring and testing takes place on a daily basis and officials are notified immediately if there are any problems.

### **Councillor Johnston**

Councillor Johnston reminded Council members of the Commuter Challenge which was scheduled to take place on May 30<sup>th</sup> and urged all Council members to take different modes of transportation.

#### Councillor Der

Councillor Der read from a letter from Burnaby South Secondary School Alumni advising that Councillor Gary Begin, a former student of the school who has achieved many accomplishments over the years, is being recognized by the Alumni at a ceremony on Monday, May 29<sup>th</sup> at which time he will be presented with the Burnaby South Alumni Award. On behalf of Council, Councillor Der congratulated Councillor Begin for being the recipient of this prestigious award.

Councillor Der gave notice of her intention to introduce the following motion regarding the Burnaby Lake Dredging Program at the June 12, 2000 meeting of Council:

- WHEREAS Burnaby and the GVRD are working together to prepare a contemporary management plan for Burnaby Lake Regional Nature Park, and
- **WHEREAS** establishing priorities and actions for rejuvenation of Burnaby Lake is an environmentally sensitive way is an important and integral decision for the management plan, and
- WHEREAS Burnaby Lake is one of the water bodies within the Greater Vancouver region with significant ecological value, and
- **WHEREAS** sediment deposits in Burnaby Lake have become a major concern for the future survival of the lake, and
- WHEREAS the pilot dredging project carried out by the City in 1999 with partial funding assistance from the GVRD has confirmed that a large scale dredging program for Burnaby Lake is technically and environmentally feasible.

### THEREFORE BE IT RESOLVED THAT:

- 1. Council approve the use of Gaming funds for the rejuvenation of Burnaby Lake based on the Council approved management plan, and
- 2. Council request additional funding allocation from the GVRD and the senior Government in support of a large scale dredging program, and
- 3. Staff be asked to pursue discussion with regulatory agencies to confirm the feasibility of an extended large scale dredging program for Burnaby Lake, and
