The Executive Committee of Council submits the following recommendations for Council's approval:

#61/99 Ribbons of Life Project - Burnaby Hospital Foundation

RECOMMENDATION:

1. THAT this grant application be denied.

REPORT

An application was received from Burnaby Hospital Foundation requesting a grant for the "Ribbons of Life" project. This project is divided into two parts. The first part is an artist outreach program to long term residents at Burnaby Hospital. The second part is a touring element whereby the works are displayed at other hospitals and long term care facilities.

Seniors at the Burnaby Hospital will be taught, through a 'visiting' artist program, a variety of techniques to create a work of art. Upon completion of the works of art, a jury (including one of the visiting artists) will select works of art for a tour of various hospitals and long term care facilities.

REPORT

An application was received requesting a grant to fund the services and programs provided by the organization.

During the past year, Burnaby Family Life Institute has continued to participate in community development initiatives. Co-ordination, collaboration and effective partnerships with the Burnaby School District, the Health Unit. Parks and Recreation and other community based agencies continue to be the cornerstone of the organization's service delivery. Burnaby Family Life Institute has continued efforts to address the needs of families who experience multiple challenges including language and cultural barriers, poverty, family violence, survivors of trauma/abuse, depression, teen partents, parenting alone, separation/divorce, special needs children and other hardships.

#5/2000 Organization For Assistance and Services to Italians (O.A.S.I.)

REPORT

O.A.S.I., a non-profit society duly incorporated under the Societies Act in 1985, assists Italians, Italo-Canadians and other people from the City of Burnaby with the following matters: pension, income tax, housing, family, legal, medical, welfare, workers compensation, translation and immigration. The organization is requesting a grant to prepare updated booklets and information in Italian and English regarding the above noted services.

The Executive Committee of Council recommends that a grant in the amount of \$2,000 be awarded to O.A.S.I. for 2000.

#6/2000 Comitato Attivita Scolastiche Italiane (CASI) School

RECOMMENDATION:

1. THAT a grant in the amount of \$2,500 be awarded to CASI to assist with the acquisition of new books and materials for school students in 2000.

REPORT

An application was received from CASI requesting a grant to assist with the acquisition of new books and materials for school students.

CASI is a non-profit society duly incorporated under the Societies' Act in 1980. The school offers Italian heritage language instruction to Italo-Canadian and Canadian children. At present, approximately 600 students, who reside in Burnaby, are enrolled in the program. New books and materials are required in order to maintain a professional level of instruction.
