- A) **Mr. Tom Kovar**, Refinery Manager, Chevron Canada Limited, 355 North Willingdon Avenue, Burnaby appeared before Council accompanied by Mr. Jason Danchin, Environment and Safety Manager and Mr. Ray Lord, Manager of Community Affairs. Mr. Kovar advised that the purpose of appearing before Council was to provide additional information and clarification on the MTBE investigations at the Chevron Burnaby Refinery.

Mr. Kovar advised that he would be covering three subjects, namely:

- provide facts and clarification on recent events regarding MTBE on Refinery property
- provide an update and progress report on the ongoing environmental review studies
- address the communications surrounding the issue to date.

The speaker advised that Chevron Canada is committed to operating its facilities in an environmentally sound and socially responsible manner and they take their responsibility to do so very seriously. Chevron wishes to ensure Council that the health and safety of its employees and the community is of utmost importance and will not be compromised. Mr. Kovar apologized if Council or members of the community perceived in any way that Chevron has miscommunicated or been less than open. Chevron is committed to open dialogue with the community and other regulatory agencies and Mr. Kovar advised that he will discuss an important change to the communication process later in the presentation.

Mr. Jason Danchin, Environment and Safety Manager addressed Council and defined the boundaries of Chevron Refinery. Mr. Danchin advised that MTBE has been present at the Refinery since 1992 and is used as a gasoline blending component and has been discontinued since 2000 October. Chevron has and will continue to review all MTBE handling protocols and have reinforced awareness amongst all operations and maintenance staff of the importance of keeping this material where it should be.

Mr. Danchin then provided Council with an overview of the Seacor Study and an update on the three independent studies which are ongoing at this time. Chevron has requested Seacor to move forward on the aggressive development of a remediation plan with the focus on interception and remediation of any contaminated groundwater which may be moving towards the perimeter of the site.

In concluding the presentation, Mr. Tom Kovar, Refinery Manager advised that Chevron Canada will continue to work proactively and cooperatively with all government representatives. Chevron has always intended to communicate with the City and the public once remediation plans were finalized. In future, Mr. Kovar advised that Chevron will endeavour to communicate more effectively to ensure that the City is informed of its remediation discussions with the Ministry of Environment, Lands and Parks. Chevron Canada therefore commits to:

- move forward with remediation plans that may arise from the Golder Perimeter Groundwater Study or subsequent studies;
- make a sincere commitment to inform the City of Burnaby staff, on a timely basis, of ongoing communications between Chevron and the Ministry of Environment; and
- openly and fully communicate the results of the review studies when the results become available.

Arising from consideration of points raised in the presentation, Council requested the following:

1. A recent material safety data sheet;
2. The reaction from the Workers' Compensation Board regarding the MTBE spill;
3. Copies of all reports from Seacor, and any other company, that have been provided to staff and the Citizen Advisory Panel ;
4. Chevron to host an open house to provide all information to the community;
5. Information on the levels of MTBE which create a degree of danger and health impact;
6. Chevron write a letter of thanks to the two Alpha students who found the off-site MTBE; and
7. More specific information on the level of contamination which was detected off-site and address the issue of contamination to the north of the railroad tracks to Burrard Inlet.

B) Mr. Ray Robb, Head of the Industrial and Air Pollution Prevention, Lower Mainland Region, Ministry of Environment, Lands and Parks appeared before Council to discuss provincial regulatory roles in monitoring activities at Chevron Refinery. Mr. Robb advised that the GVRD administers air discharges to the environment within the GVRD area. All other waste discharges are administered by the Ministry of Environment's Pollution Prevention Program. The Pollution Prevention Program is funded by fees paid by dischargers and the Ministry reports to the Minister and is accountable to all British Columbians.

The speaker advised that, in May 2000, the community sought broad Ministry involvement at Chevron and requested health, safety and compliance assessments. In response, Chevron agreed to safety, compliance and groundwater assessments and to involve the public in the design of safety, compliance and off-site groundwater assessments. The Ministry further agreed that on-site groundwater work would not be disclosed unless necessary and lastly to provide UBC funds for an independent health assessment.

With regard to the health study, Mr. Robb advised that UBC has undertaken the study and that the Ministry, the GVRD and Chevron are assisting. Terms of Reference were developed following consultation with stakeholders and it was determined that an expanded study required additional funds. As a result, some delays were experienced but the Ministry still hopes to meet target completion of December 2001.

In concluding his presentation, Mr. Robb advised that the Ministry of Environment, Lands and Parks will work with Burnaby and community representatives regarding the Chevron Safety, Compliance and Groundwater Assessments. The Ministry will continue to provide input into the Human Health Risk Assessment being undertaken by UBC and will proceed with amendments of Chevron permits.

Councillor Corrigan retired from the Council Chamber at 8:25 p.m.

Council also requested staff to review and include in a future report if there was a tank malfunction prior to 1997 that may have released MTBE on site and if there have been any studies to date which have looked at migration of any contaminants, other than MTBE, which are migrating in the groundwater and if there are any dead areas adjacent to Chevron Refinery.

Council further requested information on any previous studies on contamination concentrations that may have been conducted.
