A) Mr. Bob Gunn, Chair of the Burnaby Lake Park Association appeared before Council to discuss the proposed dredging program for Burnaby Lake. Mr. Gunn introduced George Clulow, Past Chair and founding member of the Burnaby Lake Park Association who was also in attendance to discuss the proposed rejuvenation of Burnaby Lake.

Mr. Gunn provided Council with an overview of the Burnaby Lake Park Association including membership, mandate and the many accomplishments achieved by the Association over the past years.

The speaker advised that the Association has always supported and maintained a cooperative working relationship with the GVRD and the City of Burnaby. The mandate of the Association is to preserve, enhance and protect the natural environment of Burnaby Lake Regional Park while advocating respect, appreciation and enjoyment of the Park's natural attributes and recreational resources.

Mr. Gunn further commented that, in more recent years, the Burnaby Lake Park Association, in partnership with GVRD Parks and the City of Burnaby, have continued to enhance and steward the Park through many initiatives such as sponsoring community events like lake clean-ups, educational interpretive walks, removal and control of plants, goose control program and participation in Park and community plan processes, to name a few.

In conclusion, Mr. Gunn thanked City Council and staff for their support and acknowledged that, as a group, they look forward to a long and productive partnership with the City and other community partners.

Mr. George Clulow addressed Council and recalled the delegation from the Rowing Club who appeared before Council in December, 2000 for the purpose of sharing their vision for Burnaby Lake as a site for an international rowing course. Mr. Clulow advised that the Burnaby Lake Park Association wished to provide Council with an alternate vision; one with a long history and much support in the community. Mr. Clulow made it clear that he was not presenting a competing position but rather a more expansive and inclusive vision, a position which does include rowing.

The speaker advised that the designation of Burnaby Lake as a wildlife sanctuary is one which the current Council should not erode. The Lake offers education, recreation and conservation. Rowing is one of the recreational activities that has held a long and compatible history with the values that much of the community places on the Park.

However, the speaker suggested that as the project proceeds, it must be done properly. The dredging of the Lake which took place in 1973 should not and cannot be followed today. In many respects, the community is still suffering from the legacy of that dredging program. To ensure that past mistakes are not repeated, Mr. Clulow suggested that the project must not have a narrow agenda which will leave the City to deal with a set of cascading problems that were caused by not asking the important questions at the start.

Mr. Clulow posed the following preliminary questions:

- how can the lake be dredged to derive environmental benefits?
- what should those environmental benefits be?
- how will dredging affect the existing eco systems in the lake?
- how can we preserve the environmental values of the lake and have a rowing course too?
- can we limit the size and scope of facilities and their impact or are we on the slippery slope of ever increasing demand to meet the needs?
- will the City work with the GVRD?
- are there times when and places where dredging should not be done?
- how will more intensive use of the lake affect the experience for the people attending the Park?

Mr. Clulow advised that the Burnaby Lake Park Association is offering the City its good will and collective knowledge and skills to the process. Unfortunately, rumours regarding Council's views on the future of the Lake are circulating and it is the Association's wish to move forward in a fair and cooperative manner.

In concluding his comments, Mr. Clulow advised that the Association supports the process outlined in the report of the Environment and Waste Management Committee which appears elsewhere on the Council agenda. As such, Mr. Clulow urged Council to adopt an open-minded approach to the rejuvenation of Burnaby Lake.

A) Environment and Waste Management Committee Re: Burnaby Lake Rejuvenation Project

The Environment and Waste Management Committee submitted a report providing Council with the requested information and to seek approval of an overall rejuvenation strategy that will enhance the lake environment while providing opportunities for competitive rowing events on Burnaby Lake.

The City and the GVRD have been working together in preparing a management plan for the Burnaby Lake Regional Nature Park. The goal of the management plan is to provide a balanced approach towards lake rejuvenation and appropriate recreation/sport opportunities. Under the current draft management plan process, the park is seen as an oasis of natural habitat in the core of an urban environment and for the enjoyment of the general public with selected recreation/sport opportunities.

The Committee further advised that without a rejuvenation plan for the lake, gradual infilling of the lake caused by upstream sediment transport and the invasive vegetation growth in the shallower water would eventually eliminate the open water areas and transform the lake into a marsh. The potential loss of open water, habitat types and the rowing/canoeing opportunities would be unfortunate. In 1999 a pilot dredging program was conducted and confirmed the technical and environmental feasibility of a full scale dredging program for the purposes of restoring the lake environment and enhancing the lake biodiversity as well as creating opportunity for rowing activities. The dredging

program is one of the many recommended projects included in the Brunette Basin watershed management plan which was developed over a 3 year period involving the senior governments, regional district, local governments and watershed stakeholders.

The work program outlined in this report provides a framework for the environmental and engineering review required under the provincial and federal legislation and for the stakeholders consultation process. The estimated cost of the full recommended rejuvenation project is between \$24M and \$27M. The project would allow strategic dredging to improve lake environment, removal of excess sediment built up and creation of an international standard rowing course over a 4 year period. To pursue the implementation of the rejuvenation plan, it is recommended that Council endorse, in principle, the dredging Scenario 2 as outlined in this report and seek cost sharing from the senior governments under the Infrastructure Canada program and work with the GVRD to explore additional cost sharing opportunity. The final dredging scenario will be dependent upon the results of the Environmental Review Assessment.

The Environment and Waste Management Committee recommended:

- 1. THAT Council authorize staff to proceed with Steps 1, 2 and 3 of the work program as outlined in Section 6 based on the potential dredging program including a rowing course to international standards and further, report back on the results of the work.
- 2. THAT Council authorize staff to forward an application to the Senior Governments for a funding grant (two thirds of project cost) under the Infrastructure Canada program.
- 3. THAT Council authorize staff to retain a project consulting team to undertake the environmental assessment and preliminary engineering design work for the proposed dredging program in accordance with the requirement of the BC Environmental Assessment Act.
- 4. THAT Council authorize a budget allocation of \$400,000 from Casino Gaming Funds to finance the environmental assessment and preliminary engineering work.
- 5. THAT further discussion be held with the GVRD to explore cost sharing opportunities for the proposed rejuvenation project.
- THAT a copy of this report be forwarded to the Parks & Recreation Commission, GVRD Park Committee, GVRD Parks Department, Burnaby Lake Park Association, Friends of Burnaby Lake and Burnaby Lake Rowing Club.

The Committee further agrees that the issue of changes in fee structure to allow a shared ride system would be best dealt with on a regional level as part of a larger process involving the MCC and all Lower Mainland municipalities.
