The Committee explored three collection options: city wide limit on cans/bags size and weight, semi-automated collection and fully automated collection. The Committee is recommending that the container size and weight limit option (Alternative 1) would meet the current needs of the City.

The Committee also advised that the Workers' Compensation Board (WCB) is aware of the review conducted by the City and has indicated its preference toward the semi-automated and fully-automated options from a worker injury risk management perspective. However, in view of the significant capital expenditure for either of the automated options, the Committee concluded that it would be prudent for the City to adopt Alternative 1 as the first step toward reducing work related injuries in the waste collection service division.

The Environment & Waste Management Committee recommended:

- 1. THAT Council approve the City-wide limit on cans/bags size and weight and review of the task system (*Alternative 1*) as outlined in this report.
- 2. THAT Council authorize initiation of a public communication program to advise affected Burnaby residents of the proposed collection service improvement.
- 3. THAT Council authorize the City Solid Waste Bylaw to be amended accordingly and put into effect in early May 2001.

- g. The dedication of any rights-of-way deemed requisite.
- h. Completion of the Highway Exchange Bylaw.
- i. The deposit of the applicable GVS & DD sewerage charge.
- j. The approval of the Ministry of Transportation and Highways to the rezoning application.
- k. The provision of facilities for cyclists in accordance with Section 4.6 of the rezoning report.
