REPORT

A request to use a City street and laneway for a community Festival on Saturday, 2002 September 14, 7:00 am to 4:00 pm has been received from Reverend K.I. MacDonald of the South Burnaby United Church. Council approval is required by the Street & Traffic Bylaw.


The South Burnaby United Church is requesting the use and closure of the road and laneway in the rear of their property (7591 Gray) and Gray Avenue from Irwin to Rumble, see attached map, for their second Fall Festival on Saturday, 2002 September 14.

The festival will allow their neighbours an opportunity to meet and participate in their various events through the day.

The organizers are aware that approval is subject to the following conditions:

1. That the road and lane closure be conducted under the supervision of one person as marshall or organizer.
2. That all participants be instructed to respect the rights and property of the individuals encountered in the laneway and on the road.

3. That the road and lane closure be covered with liability insurance in the minimum amount of \$2 million with the City of Burnaby named as co-insured, and that the insurance policy include a 30 day cancellation notice and a cross liability clause.
