At the conclusion of the 'Closed' meeting, the 'Open' meeting was reconvened at 7:00 p.m.

A) Mr. David Jones, President of the Medical Staff at Burnaby Hospital, 3935 Kincaid Street, Burnaby appeared before Council accompanied by his colleagues, Dr. Paul Wright, Dr. Normandie Chubra-Smith and Dr. Cliff Silverthorne to voice their concerns regarding the proposed reorganization of healthcare services in the Fraser Health Authority and how these changes will directly affect Burnaby Hospital and the availability of acute care services in Burnaby.

Dr. Jones advised Council that the Acting CEO of the Fraser Health Authority (FHA) has presented the Clinical Services Directional Plan and, as noted from the proposal, sweeping changes are planned for the entire FHA. The Executive is approaching the FHA as a single hospital with multiple sites and, with that frame of reference, every site has been considered for reconfiguration. The overriding principle behind this reconfiguration is the need to manage the inpatient resource in the most efficient way possible. This plan divides the inpatient population into acute care and sub-acute care classifications and the reconfiguration of hospital sites is defined along those lines.

The speaker noted the following as some of the major changes planned:

- the current bed capacity at Burnaby Hospital is 238 of which 190 to 200 have been operating on an ongoing basis. The new configuration will create a site with 150 to 200 beds, split between acute care and subacute care. Dr. Jones noted that the exact definitions of these terms is unclear but basically translates to a reduction of acute care beds in Burnaby Hospital to a total of somewhere between 0 and 50;
- the Surgical Program will not be providing after hours urgent and emergent surgery, except for C-sections;
- further changes planned are the conversion of the Critical Care Unit to a Maxi-Unit;
- there is also the possibility of the movement of inpatient psychiatric services on-site;
- inpatient Paediatrics will be closed and shifted to 3 sites only, RCH, SMH and MSA;
- there are plans to include specialty outpatient and primary care services in the reconfiguration.

The speaker also noted that Burnaby Hospital has recently experienced 42 staff layoffs. There is a mounting campaign to save the Hospital as an acute care facility as the only other acute care facilities in close proximity for Burnaby residents are Surrey Memorial Hospital and Royal Columbian Hospital. Last year, Burnaby Hospital treated over 55,000 patients in the Emergency Department, conducted over 2,000 emergency surgeries, 6,500 elective surgeries and delivered 1,700 babies. Also, the Hospital received over 3,000 admissions for severe medical conditions, had over 11,000 outpatient treatments over 6,000 cancer clinic visits and conducted over 1 million laboratory tests.

Dr. Jones expressed his surprise at the bold changes that are being proposed, not only to Burnaby Hospital but throughout the entire hospital sector in the FHA. Dr. Jones and his colleagues urged Council to lobby Burnaby's MLAs to ensure they are aware of the impact the proposed changes will have on Burnaby residents and to ask what they intend to do to keep Burnaby Hospital as an acute care facility and to assure reasonable and timely access to health care for the residents of the community. In concluding his presentation, the speaker offered his commitment to continue to work with the medical staff to assure that quality of patient care comes first, particularly in the face of this adversity.

Councillor Corrigan retired from the Council Chamber at 7:50 p.m.

A) Finance and Economic Development Committee Re: Government Road Neighbourhood Access <u>To/From Lake City SkyTrain Station</u>

The Finance and Economic Development Committee submitted a report providing additional information on wrought iron fencing as an element of the access improvements for the Government Road Neighbourhood as previously approved by Council. The Committee advised that Option 3 - "Restricted Access", as adopted by Council, offers a balance between directing strangers away from Charles Rummel Park and Seaforth Elementary School while allowing access to all areas of the neighbourhood. Option 3 restricts public access to two points of entry/exit on either side of Charles Rummel Park. In total there is about 1,150 metres of fencing proposed to restrict access to these two entry/exit points and to better define the limits of Charles Rummel Park and the nursery. By converting the material proposed for the 310m section of fencing between Lozells and the nursery, the overall set of access improvements would be made to be far more resistant to vandalism (particularly fence cutting) and could significantly reduce the amount of maintenance required. It would present a more finished appearance along the northern edge of Charles Rummel Park and the additional initial capital cost will likely be partially off-set over time by maintenance cost savings.

The Finance and Economic Development Committee recommended:

- 1. THAT Council approve the use of wrought iron fencing between Lozells and the nursery as outlined in Section 3.0 of this report on the understanding that the tender bids come within the estimated budget amount for this item.
- 2. THAT Council bring down a Capital Reserves Expenditure Bylaw in the amount of \$398,000 for the construction of the Government Road neighbourhood access improvements outlined in Section 3.0 of this report over a two year period.

2. City of Coquitlam Bylaw 3498 - Amendment to Citywide Official Community Plan

The City Manager submitted a report from the Director Planning and Building providing comment on Bylaw 3498, an amendment to the City of Coquitlam's Citywide Official Community Plan (OCP) to include the Burquitlam and Lougheed Neighbourhood Plans. Staff advise that, in reviewing the amendment, it is recommended that the City of Burnaby request the City of Coquitlam to amend Schedule B-1 of the Citywide OCP and Schedule B of the Lougheed Neighbourhood Plan to reflect the conceptual alignment of the SkyTrain guideway along the centre line of North Road between Austin Avenue and Cottonwood Avenue, as approved by the TransLink Board at its meeting on 2000 December 13. Staff also recommend that Burnaby request Coquitlam to confirm that these changes have been made prior to the adoption of Bylaw 3498.

In terms of other transportation related issues, staff recommend that the City of Coquitlam design the proposed new east-west road south of the Lougheed Highway to align with Rochester Street in Burnaby and to designate Lougheed Highway east of North Road as a commuter cycle route, similar to its designation in Burnaby.

Staff conclude that, apart from transportation related issues, the goals and policies contained in the Lougheed and Burquitlam Neighbourhood Plans are generally supportable and would not conflict with policies and goals contained in Burnaby's OCP.

The City Manager recommended:

- 4. THAT, following First Reading of the amending bylaw for the Burnaby OCP Bylaw No. 10709, a copy of the adopted Development Plan for the subject Commercial Precinct and the subject amending bylaw be forwarded to the GVRD Board, the Land Reserve Commission and the cities of Vancouver, New Westminster and Richmond, for comment as required under the Local Government Act.
- 5. THAT, subject to completion of the referenced OCP bylaw amendment, staff be authorized to forward applications to the Land Reserve Commission for exclusion of City lands and private lands within the Commercial Precinct.
