A) Mr. Bill Lambert, Program Manager, Project Planning, TransLink appeared before Council to provide a brief update on the Burnaby New Westminster Area Transit Plan. In terms of Area Plan goals, Mr. Lambert advised that TransLink will identify service improvement priorities, provide more flexible and responsive systems (e.g. community shuttles), optimise existing routes, respond to crowding and attract new markets.

Mr. Lambert advised that potential regional improvements include faster and more direct connections between New Westminster-Burnaby, Central Broadway and Downtown Vancouver, Richmond, the Northeast Sector and the North Shore. Increased frequency and improved services within Burnaby-New Westminster focus on regional and municipal town centres, SFU and the Willingdon corridor. The speaker also suggested potential local improvements to the north-south connections in Burnaby, the Canada Way/8th Street corridor, service to proposed SkyTrain Stations, Discovery Park, the Lake City area, eastwest along Rumble Street and the Big Bend area.

In addressing SkyTrain security improvements, the speaker outlined proposals to enhance visibility and provide retail opportunities. Fifteen additional constables and 45 full-time and 16 part-time ticket checkers will be hired.

Mr. Lambert concluded his presentation by providing the following timeline for the Burnaby New Westminster Area Transit Plan completion:

- Conduct initial consultation (Complete)
- Review ridership and route performance (Complete)
- Develop service options (Complete)
- Market research and modelling (Underway)
- Public consultation (Underway) (...cont'd)

- Develop draft plan (January-March)
- Approval in principle by TransLink Board (March)
- Municipal review (March-April)
- Final approval by TransLink Board (May)

- h) The deposit of the applicable Parkland Acquisition Charge of \$3.84 per sq. ft. of gross floor area.
- i) The deposit of the applicable School Site Acquisition Charge of \$900.00 per unit.

9. Provincial Government Closure of the Burnaby Courts

The City Manager submitted a report from the Director Finance providing initial comments on the contemplated impacts from the closure of the Burnaby courts by the Provincial government.

Staff advise that, on 2002 January 17 the Provincial government announced the closure of the courts operated from the Burnaby Municipal Justice Building. The Burnaby Provincial Court is reported to be one of B.C.'s busiest and currently houses four courts. The courthouse closure creates a great deal of uncertainty for the City and it is likely to take considerable time for all the details of the closure, other cutbacks and their consequences to become known. Staff indicate that matters of financial concern, logistics, practical and operational requirements and social impacts will need to be addressed.

Staff conclude by indicating that Burnaby is a rapidly growing urban community of almost 200,000 residents which is served by a sophisticated and complex system of interconnected and interdependent social services. The removal of the court - a key component of that service delivery system - is likely to have a considerable impact on the effectiveness and efficiency of the entire system and will be a retrograde step in relation to the third largest city in the province.

AND WHEREAS there will be a significant impact on the City budget due to the direct loss of revenues from rental, taxes and services provided by the City of Burnaby;

AND WHEREAS there are further substantial costs to the City as a result of increased overtime and expenses associated with travel by Burnaby RCMP officers in order to attend at court for various functions, including particularly the giving of evidence as witnesses;

AND WHEREAS there will be a concurrent loss of service coverage in our community because the officers will be unable to attend to other duties while awaiting court and will be unavailable for their regular duties for a longer period of time than necessary;

AND WHEREAS there will be unwarranted and unfair difficulties placed on all Burnaby citizens who are required to attend court, including additional time, cost and inconvenience for witnesses and victims of crime;

AND WHEREAS the integrity of the justice system in our community will be affected by failures to appear by accused persons, delays caused by travel problems, cases lost due to the non-attendance of witnesses and increased problems for Crown Counsel in preparing their cases;

AND WHEREAS the ability of our citizens to attend court and to see justice being done in our community is a cornerstone of the democratic process and ensures local community interests are preserved;

AND WHEREAS the real cost savings to the Provincial Government are very doubtful, given that various persons employed or funded by the Provincial Government will also be required to travel great distances to perform their duties, including probation officers, social workers, child protection workers, medical personnel and many others.

THEREFORE BE IT RESOLVED that the City of Burnaby, on behalf of all of its citizens, objects in the strongest possible terms to the closure of the Burnaby court facilities and demands the immediate reinstatement of all court services within the Burnaby community;

AND FURTHER BE IT RESOLVED that the City of Burnaby advise the Provincial Government that it is appalled by the failure of the Provincial Government to consult with City Council or the citizens of Burnaby before making such an ill-advised decision on an important and essential local service;

AND FURTHER BE IT RESOLVED that a copy of this motion and the related staff report be forwarded to the Premier, the Attorney-General, the Solicitor General and the four Burnaby Members of the Legislative Assembly;

AND FINALLY BE IT RESOLVED that the City of Burnaby seeks the assistance and support of the four Burnaby MLA's in vehemently opposing this short-sighted and high-handed decision by the Provincial Government Cabinet."
