Councillor Harris advised that she had contacted the CEO the day after the forum to ask why the GVRD had not responded to requests from Burnaby City Council arising from her motion of July 23 seeking information on air quality before and after the transit strike. The explanation provided by the CEO was that there had been a report on the matter but it had been pulled from the GVRD Planning and Policy Committee agenda. The CEO gave assurances at that time that the report would soon be back on track and therefore Councillor Harris questioned when this would take place.

In response, His Worship, Mayor Drummond undertook to provide a copy of the GVRD Planning and Policy Committee report to Council as soon as it is made available.

Councillor Der

Councillor Der inquired if any members of Council were planning to attend the Provincial Congress on February 26th in Vancouver which will bring together all B.C. MLA's, Members of Parliament and Senators, Mayors from the Province's 15 largest cities, presidents of the five regional municipal associations, the President of the UBCM and aboriginal leaders.

In response, His Worship, Mayor Drummond confirmed that he had received an invitation and would be attending the Congress. Mayor Drummond also indicated that he had prepare several questions to bring forward at the Congress.

Councillor Der requested that a full report be submitted to Council detailing the outcome of the questions asked which relate to Burnaby and the answers provided.

Councillor Der referred to the Ground Water Association Annual Conference which is being held in Kelowna, B.C. from February 28 to March 2nd and inquired if a Council or staff member would be attending.
