REPORT

1.01 Background:

The following is a summary of the construction progress and expenditures for the Observation and Announcing Tower project at Burnaby Lake Sports Complex-West.

Following the award of a construction contract to CDC Construction Ltd. by Council, the contractor commenced work in 2001 June and substantially completed the project on 2002 January 08. The facility has subsequently been turned over to the Parks Department for use.

The Tower is a sheet framed structure approximately 19 feet in diameter and 30 feet in height. The main viewing level is located 17 feet above field level and has connections for telephone, data, score clock control and the existing Public Address system. The fully retractable windows provide 150 degrees of open viewing on each side for filming, viewing, and score keeping of events on Fields 1 and 3. The roof deck which is located 27 feet above grade provides 360 degree viewing of this facility and is intended for the filming of events.

The overall workmanship is of good quality and the project was completed within the approved budget for Burnaby Lake Sports Complex-West. The following financial summary outlines the final project costs for the Observation and Announcing Tower at Burnaby Lake Sports Complex-West.
