Councillor Corrigan arrived at the Council meeting at 7:08 p.m. and took his place at the Council table.

Councillor Fearnley provided an overview of the LMMA Action Plan to initiate a co-ordinated drug strategy on a region-wide basis involving a broad range of stakeholders.

The speaker also outlined the major goals of the action plan including primary prevention, precautionary harm reduction measures and crime control, drug supply reduction and law enforcement efforts.

The proposal targets illegal use of cocaine, heroine and methamphetamines as the most addictive and dangerous of illegal drugs.

The speaker concluded by requesting Burnaby Council pass a motion supporting the LMMA's Regional Action Plan to reduce the harmful effects of alcohol and drug misuse and to start developing a made in Burnaby drug and alcohol strategy.

Arising from the presentation, Councillor Corrigan was granted leave to introduce the following motion:

**B)** Mr. David Black, Executive Member, OPEIU, appeared before Council to discuss the Provincial Government's proposal to allow private insurance companies to sell basic auto insurance.

Mr. Black contends the loss of public insurance would mean higher rates for younger drivers, seniors and families with younger drivers; the doubling or tripling of insurance rates; the end of ICBC Road Safety Programs; the increase in the number of uninsured drivers on B.C. roads; loss of jobs; fewer claim centres; loss of the 24 hour claim service; loss of regional services; and loss of the Crime Watch Program.

The speaker noted that under NAFTA once ICBC is eliminated, public insurance cannot be reinstated without paying a severe financial penalty.

The speaker advised that in 1999 ICBC contributed in excess of \$150,000 towards City of Burnaby traffic safety projects. The loss of ICBC as a public insurance company would mean a loss of those traffic safety program dollars.

In conclusion, Mr. Black requested Council write to the Provincial Government requesting them to maintain public automobile insurance.

# PURCHASING PROVISIONS OF THE AGREEMENT ON INTERNAL TRADE (AIT) AND THE B.C. MUNICIPALITIES

#### CITY OF BURNABY

"THAT WHEREAS, B.C. municipalities already comply with the intent of the procurement provision rules of the Agreement on Internal Trade (AIT) and enshrining these rules in legislation opens an avenue of challenge based on creative interpretations placing municipalities in a position of unnecessarily defending legitimate criteria set for tenders, with no discernable benefits being achieved by the legislation;

AND WHEREAS, the dispute resolution process denoted in the AIT is contrary to the stated spirt of the Community Charter, potentially leading to decisions that are detrimental to the achievement of municipal objectives and good governance through the exclusion of municipalities from the dispute resolution process:

THEREFORE BE IT RESOLVED that the municipalities of B.C. be on record as being opposed to inclusion in the purchasing provisions of the AIT, and the Province be requested to commit to full consultation with the municipalities before adoption of any further changes to the AIT,

AND BE IT FURTHER RESOLVED that in the absence of rescinding the legislation the Province commit to pay any and all costs, regardless of outcome, arising from disputes under the AIT."

#### 7. <u>INQUIRIES</u>

#### **Councillor Harris**

Councillor Harris inquired about the study from the GVRD on the air quality impact of the recent transit strike. Councillor Harris advised that an air quality report was pulled from the Council of Council's agenda in 2001 September because it was considered inconclusive; however, Councillor Harris contends the February Committee report provided by the GVRD is also inconclusive and asked if these were the same report or two different reports. Councillor Harris also inquired as to when a full and complete report would be available.

Councillor Redman advised she has recently been made aware the Provincial Government is no longer funding the construction of dykes and inquired as to the impact of the removal of this program for Burnaby.

The Director Engineering, Mr. W.C. Sinclair, advised that Burnaby will be one of the least affected municipalities by withdrawal of this program.

#### Councillor Der

Councillor Der advised that the Federation of Canadian Municipalities is designating April 30 as Municipal Government Day in Canada and inquired whether or not Burnaby is planning any activities to celebrate this day.

His Worship, Mayor D.P. Drummond advised he will look into the matter.

Councillor Der inquired whether or not the recent loss of \$1.3 million in revenue from Provincial downloading will affect property taxes in 2002.

Councillor Corrigan, Chair, Finance and Economic Development Committee, advised the City is trying to absorb the \$1.3 million loss so that property taxes will not be unduly impacted in 2002.

#### Councillor Redman

Councillor Redman advised that she has received notice from the GVRD regarding the 2002 Globe Conference in Vancouver and expressed an interest in attending the conference.

The City Manager, Mr. R.H. Moncur, advised that staff will provide Councillor Redman with a registration package for her consideration.
