#### **2002 LOCAL HERO AWARDS**

***Presenters: Acting Mayor, Councillor Gary Begin  
Councillor Dan Johnston, Chair, Community Issues and  
Social Planning Committee]***

By way of introduction, Acting Mayor, Councillor Begin advised that Local Heroes are individuals who have made an important contribution to our community over several years. The City takes great pride in recognizing these people. Whether quietly working behind the scene or helping out on the frontline, Councillor Begin advised that each of Burnaby's 2002 Local Heroes has given freely of his or her time in making Burnaby a better place to live.

Each year since 1997, the Community Issues and Social Planning Committee has recommended a list of Local Heroes to be considered for recognition. With tonight's nominees, Councillor Begin noted that Burnaby will have recognized 72 Local Heroes since the program's inception.

Acting Mayor, Councillor Gary Begin invited Councillor Dan Johnston, Chair of the Community Issues and Social Planning Committee to come forward and formally recognize the City of Burnaby's 2002 Local Heros.

Councillor Dan Johnston, Chair, Community Issues and Social Planning Committee, with the assistance of Acting Mayor, Councillor Begin introduced the following Local Hero recipients and presented them with certificates of appreciation:

***Norm Sandercock:*** Norm has volunteered for the Conservation Department at Burnaby Village Museum since 1994. Prior to that time, Norm volunteered in the restoration of the 1912 Parker Carousel which is now in use at the Museum. He also volunteered with the Scout movement in Burnaby during the late 1960s and 70s. He has been a longstanding member of the Burnaby Historical Society and more recently, of the Friends of Interurban 1223. Staff at the Museum credit him with the ability to figure out how anything works. His nominator adds, *"Whether designing his projects in his dreams or sketching them at the breakfast table, Norm has made each contribution with love."*

***Elizabeth Briemberg:*** Elizabeth volunteers as a group facilitator of two programs at the Burnaby Family Life Institute. She is the leader of a support group for single parents for three eight-week sessions per year. She devotes much time before and after each session listening to parents and providing resource information. She also facilitates a weekly program called *"Canadian Life Information"* which provides information and support to newcomers to Burnaby. Her nominator describes her as having an open, kind and inclusive manner which helps to make immigrants feel welcome. Her nominator further adds, *"Elizabeth is definitely making a difference in Burnaby."*

***Steve Cairns:*** Steve is described as someone who has gone above and beyond his duty as the principal at Buckingham Elementary School. His nominators state that, over the years, he has consistently *"gone the extra mile"* to support students, teachers, families and the broader community. His care and concern for individuals and the community was exemplified this past Christmas when he intervened on behalf of two children at the school who had experienced serious family troubles and were in need of foster care. Steve ensured that the children were placed in a safe and loving home in the community in time for Christmas. In the words of his nominator, *"Steve believes that love and showing that we care is everyone's responsibility."*

**Millie Canessa:** Millie has been involved in Burnaby community life for many years. She has volunteered with many organizations including the Burnaby Historical Society, Burnaby Heritage Advisory Commission, and the B.C. Old Age Pensioners' Organization, Branch 12 (Edmonds) where she served as both secretary and president. She currently volunteers with Burnaby Citizens Support Services where she take seniors out to lunch two to four days a month. Her nominator states, *"Millie has been an advocate for seniors and those in need for many years. Millie is an extremely caring individual, not only voicing her concerns, but actively and tirelessly working towards creating a better life for those without a voice."*

**Kenney Chan:** Kenny has been volunteering at Eastburn Community Centre for more than ten years, six days a week. He is known by the staff at the centre as their *"super volunteer"*. Kenney helps out with photocopying, room set up, special events and cleaning. In the summer, he volunteers with recreation programs for youth at Richmond Park. He also helps prepare hot lunches for seniors at Edmonds Community Centre. His nominator states, *"Anyone who has ever been in the centres, or at the park, will know Kenney because of his caring, friendly and giving nature."*

**Jack Cyr:** For the past ten years, Jack has volunteered at the Variety Hotelier House Children's Centre operated by the Burnaby Association for Community Inclusion. He volunteers two days a week preparing food, assisting with the recycling, walking the children to kindergarten and supporting the staff in a variety of jobs. Over the years, he has built many special friendships at the centre. The person nominating him states, *"Jack has continuously offered his time, energy and skills of his own free will. He has made a vital contribution to the lives of the children and families we support."*

**Harvey Elder:** Harvey is currently the chair person of the East Burnaby Rate Payers Association where he has been a member for over 35 years. He was instrumental in saving the Love farmhouse (built in 1893) and having it moved to the Burnaby Village Museum. He has shared his talents as a welder, carpenter and electrician with many people and organizations and was particularly helpful in renovations for the Kids Link Day Care at Second Street Community School. He has built sets for the school's Christmas musical and cut fish for their Web of Life fence. He volunteers to deliver the school's community newsletter four times a year. His nominators note, *"We have known Harvey for decades and have always appreciated his dedication to this community."*

**Richard Harvey:** Richard has been actively involved as a volunteer repairman for the Red Cross' medical equipment loan service in Burnaby for over 10 years. During this time, he has worked two three-hour shifts each week, in addition to taking medical equipment home to repair during his own time. He has frequently augmented the Red Cross' tool supplies with his own equipment, routinely picked up overdue equipment when clients have had difficulty returning it, and has assisted programs in other communities. His nominator adds *"Richard is always willing to get in there and help."*

**Reg and Ethel Hawthorne:** Reg and Ethel Hawthorne have been citizens of Burnaby for decades. They have served as volunteers for many years with the Pastoral Care program at Burnaby General Hospital. They have also volunteered with the Dania Seniors' Home for thirty years. Their volunteer work mainly involves visiting with patients and their families, offering them care and support during difficult times. Their nominator states, *"I am very impressed with their kindness and caring and the way in which they are able to reach out and help individuals they don't even know."*

**Vivian Henderson:** Vivian was born and raised in Burnaby. Her nominator states that since her early days she has been very community minded. She served as president of the Parent Teacher Association at Second Street Elementary for four years. She became involved with the Girl Guide movement, holding many training positions, and then serving as Commissioner for the Burnaby Royal Area for six years. She has assisted with the Lions' Skate-a-thon and has been involved with the Abbeyfield seniors housing project at Curtis Street and Sperling Avenue. Her nominator states, *"For a local girl, Vivian has certainly served her community well."*

**Gail Klarer:** Gail has volunteered with Burnaby Seniors Outreach Services Society for four years. She is described as going above and beyond the call of duty in her administrative support for the peer counselling services offered by the Society. She has reached out to seniors having difficulty coping with changes in their lives to let them know about the emotional support available to them through the Society. The person nominating her states, *"She has been totally committed to the program in so far as giving unstintingly of her time, expertise and community spirit."*

**Kenny So Ying Leung:** Kenny has been volunteering with the Red Cross in Burnaby and other parts of the Lower Mainland for the past three years. Prior to her service here, she volunteered with the Red Cross in Hong Kong for 12 years. Her long service in the field of First Aid training and community liaison has made her a vital link for Red Cross operations with the local Chinese community. She has delivered First Aid programs at Burnaby College, Burnaby Family Life, and other community organizations. In the words of her nominator, *"It is our belief that she has brought much to the Red Cross as a volunteer, and to Burnaby in particular. Our partnership with the community is strengthened by her activities."*

**Nick Lutz:** Nick currently serves as president of the Metro Lions Club and was past president of the Burnaby Host Lions Club. A particular focus of his volunteer work is helping to meet the needs of blind people. He has served as chairman of the Lions' Journey for Sight walk and has organized curling tournaments for blind curlers. He works with the Canadian National Institute for the Blind helping people get the equipment they need. His nominator states, *"Nick is very diligent - he wants to finish a job once he has started it. He devotes his time to whatever he can."*

**Eleanor MacQueen:** Eleanor's years of volunteering span many decades. She has been involved with numerous programs at Burnaby Hospital including fund raising, volunteer orientation and the children's hospital tour program. She has a regular Friday shift in the out-patient oncology program where she is described as having boundless compassion for the cancer patients she assists. In total, she has contributed over 8,000 hours of volunteer time to Burnaby Hospital. In the words of her nominator, *"She has touched the lives of countless individuals."*

**Merv Magus:** Merv has been actively involved in Burnaby community life for several decades. As a teacher at Edmonds Junior and Burnaby Central Secondary schools, he served as coach for various sports and editor of school annuals. Even after retiring, he has continued to coach high school basketball teams. He was a founding member of the Burnaby Sports Recognition Dinner and was part of a team which established the Burnaby Sports Hall of Fame. In the words of his nominator, *"Merv Magus provides a wonderful example to young people and others around him."*

**Sev Morin:** Over the years, Sev has volunteered his time with many local organizations. A partial list includes Variety Club, Burnaby Hospital, Burnaby School District's Secondary School Apprenticeship Program, and the B.C. Summer Games in Burnaby. Sev currently serves with the Coast Foundation Society, the Canadian Foundation on Problem Gambling and the Burnaby Board of Trade. In his volunteer work with the Board of Trade, he is described as helping to fill all the holes, making life easier for everyone. His nominator adds, *"Sev shows his commitment to Burnaby in many different ways. This commitment, we believe, makes Sev a true Local Hero."*

**Regina Ogmundson:** Regina volunteers as a Big Sister. For the last three years, she has been a big sister and mentor to a Little Sister who lives in Burnaby. Her nominator states that because her Little Sister has been dealing with a number of difficult issues, Regina's match has been particularly challenging. Her nominator further adds that *"Regina is able to utilize her numerous attributes and skills to handle situations that come up."*

*Because of the stability Regina offers the Little Sister, the Little Sister has been able to overcome many barriers. Regina deserves to be honoured as someone who continues to give above and beyond the call of duty."*

**Hugh Robertson:** We were saddened to learn that our next Local Hero, Hugh Robertson, passed away on September 15. Hugh was a volunteer with the Lougheed Community Police Office where he put in over 700 hours of volunteer time. He participated in bike patrols that spotted and reported fires, stolen vehicles and the dumping of hazardous materials. He assisted people in making police reports and recruited numerous other cyclists to the program. His extensive knowledge of bike maintenance helped to keep program costs down. His nominator states, *"There are few of us who have made the kind of contribution to our community that Hugh has."* Receiving the award for Hugh Robertson are Staff Sergeant Daryl Stone and Cynthia Helgason of the Lougheed Community Police Office.

**Bernice Wiseman:** Bernice has been a volunteer at Edmonds Community Centre for the past five years. She started out as treasurer for the Edmonds Seniors' Society, managing the extensive finances and book-keeping of the Society which has over 25 member groups. She branched out to tending the outdoor cutting garden, overseeing the installation of a three-tiered fountain at the Centre and minding the centre's indoor solarium. She has also been instrumental in coordinating the finances of the Edmonds Food Service Program and has recently been taking courses in volunteer management. In addition, she sits as the Tenants' Resource Association in her residence and helps organize special events. To quote her nominator, *"Far more than just a treasurer, Bernice is a treasured resource wherever she volunteers."*

In concluding his comments, Councillor Johnston stated that the people being honoured have made a tremendous contribution to community well being over the years and truly deserve recognition as Burnaby Local Heroes. They have also set a high standard to be aspired to by future Local Hero nominees. On behalf of City Council, Councillor Johnston congratulated the Local Heroes and thanked them for their selfless and valuable contributions to the community.

**A) The delegation withdrew from the Agenda prior to the Council meeting.**

*Councillors Corrigan, Harris and Volkow entered the Council Chamber at 7:40 p.m. and took their places at the Council table.*

**B) Jenny Green, 7225 - 14th Avenue, Burnaby** appeared before Council accompanied by **Doris Bilcox** and **Laura Ward**, members of the Poverty Initiative's Steering Committee to present the Burnaby Poverty Profile to Council.

The speakers advised that people who live in poverty in Burnaby, and people who work for community agencies which offer social services in Burnaby, know that poverty hurts and a person who is living in poverty is limited every day in what he or she can do. Therefore, the group agreed that the daily experiences of poor people would be written so that others can understand that poor people can't do what those with money can do. It was also agreed to study statistics of income and the policies of government assistance in order to have a clearer idea of how many people are affected by poverty in the city.

The speaker went on to advise that the agencies of the Burnaby Interagency Council agreed to seek financial support from the United Way of the Lower Mainland to fund a researcher to collect people's stories, gather the statistics and produce that information in the profile. Various myths about poverty were pointed out and the delegation provided poverty statistics including information about particular populations gleaned from Statistics Canada's Low Income Cut-Off measures, or LICOs.

In concluding their presentation, the delegation put forward the following recommendations for Council's consideration:

- "We request that City Council support us to follow up talking to people in Burnaby's diverse communities about how to cooperate to reduce poverty in the City.
- We want City Council to urge both other levels of government to invest in programs which will help people in Burnaby who live below the LICOs with paying for basic necessities of life, like education, health and housing.



- We request that City Council help Burnaby Parks, Recreation and Cultural Services increase its services to
  - i) people living on low income by allowing year-long access to its facilities, not limited by a specific dollar amount,
  - ii) young people aged 19 to 24 years of age, for whom there are insufficient programs, and
  - iii) recreation facilities in the south area of Burnaby where, for example, there are no rinks or pools easily accessible by public transportation.

Arising from consideration of the delegation's presentation, Councillor Johnston was given leave by Council to introduce the following motion:

##### **A) Traffic and Transportation Committee (Transportation and Transit Division) Re: Percival Avenue Local Improvement Program**

The Traffic and Transportation Committee (Transportation and Transit Division) submitted a report advising Council of a recommended approach to address the neighbourhood traffic issues raised by residents with regard to the Local Improvement Program on Percival Avenue between Spruce and Monarch Streets.

The Committee noted that the configuration for Percival Avenue was adopted by Council as part of the rezoning of city-owned lands and subsequently included as a component of the LIP roadworks which were approved through the petition process by the required majority of residents of Percival Street. During construction of the roadworks, residents on Fitzgerald Street raised concerns regarding the inclusion of the cul-de-sac and the impact of the closure on their street from traffic to and from Burnaby Central High School.

In response to these concerns, construction of the roadworks was suspended in the area of the cul-de-sac and Council directed the Committee to deal with the matter promptly. The Committee established a Working Group which came to a consensus on an approach to address the issues of traffic safety, school-related traffic and the Percival LIP, and recommended an approach involving three themes: reduce, relocate and reroute school-related traffic.

In summary, the recommendations emerging from the process of the working group, including an open house and a questionnaire distributed in the subject neighbourhood, are to:

- work with ICBC and TransLink to reduce overall school trips;
- work with School District 41 to relocate school trips away from the west side of the school;
- complete the LIP project;
- construct a lane that would operate northbound from Percival Avenue to Spruce Street as indicated in Option "A" contained in the report; and
- provide speed bumps in the Spruce Street lane, if requested by at least four of the six adjoining property owners.

The Traffic and Transportation Committee (Transportation and Transit Division) recommended:

1. THAT Council confirm the Local Improvement Program work on Percival Avenue to be completed as originally planned.
2. THAT Council bring down a Capital Expenditure Bylaw in the amount of \$75,000 to finance the construction of a one-way northbound lane between Percival Avenue and Spruce Street and a raised centre median on Spruce Street at Canada Way, shown as Option A in **Figure 1**.
3. THAT Council authorize the installation of speed bumps in the lane south of Spruce Street between Percival and Fitzgerald Avenues, if requested by owners of at least four of the six properties that adjoin this lane.
4. THAT Council authorize staff to assess the feasibility and advisability of pursuing the traffic reduction and relocation measures identified in this report, with particular emphasis on closure of the Percival driveway of Burnaby Central Secondary School.
5. THAT Council forward a copy of this report to all residents in the study area, the Burnaby School Board and the Burnaby School Board Buildings and Grounds Committee.

**C) Bicycle Advisory Committee**

The Bicycle Advisory Committee submitted a report reviewing proposals submitted by a Committee member for alternatives to the designation of Oakland Street as a designated cycle road in the Burnaby Transportation Plan.

The Committee advised that the purpose of designating Oakland as a Cycle Road in the Transportation Plan is to provide an east-west facility for experienced cyclists to efficiently navigate between Royal Oak and Walker Avenue in the area south of Deer Lake. While it may not be inviting to novice or even some intermediate cyclists in its present form the Committee felt that marking bike lanes by adjusting the centreline and removing parking along the north side, in the manner successfully implemented in Saanich, could create a more attractive facility, broadening its appeal.

Bikeway alternatives to Oakland Street are limited due to the local topography and road layout. Development of a route in this area would have to be weighed against the priority locations identified during the recent Bikeways Open Houses.

The Committee concluded by advising that the provision of a marked route does not in any way preclude the use of adjacent roads. As most trips originate or terminate on roads which are not designated bike routes, and many short trips are by local residents familiar with their neighbourhood and would not require directional signs to accommodate them.

The Bicycle Advisory Committee recommended:

1. THAT Council approve the installation of marked bike lanes along Oakland from Sperling to Denbigh Avenue.
2. THAT Council authorize staff to investigate the advisability of installing marked bike lanes from Denbigh Avenue to Royal Oak Avenue and that the results be forwarded to the Bicycle Advisory Committee.

Staff advise that the recommended amendments to the Burnaby Zoning Bylaw flow from the neighbourhood planning process SFUCC and its consultants have been pursuing in cooperation with City staff, and recognize the unique campus context and sustainable character of the proposed community. All the proposed amendments have been discussed with, and are supported by SFUCC.

The Zoning amendments contained in the report, which are specific to the SFU Neighbourhood, are related to improving security for and location of visitor parking, inclusion of bicycle parking requirements within the Bylaw, and improving and clarifying bylaw provisions related to secondary suites in P11e Zoning districts. As indicated, while specific to the SFU Neighbourhood, staff believe the first two amendments may have applicability on a city-wide basis. As such, staff will pursue the feasibility of the proposed bylaw amendments and will provide recommendations for Council's consideration in a forthcoming report regarding these issues.

The City Manager recommended:

**4. Lougheed Berm at Braemar Gardens**

The City Manager submitted a report from the Director Planning and Building providing Council with a response to the 2002 June 21 correspondence received from Strata Corporation NW-300 ("Braemar Gardens"). The correspondence clarified that their primary concern was specifically related to "...noise from these (roadway) vehicles deflecting off the guideway." In response to this, Council directed staff to prepare a report once the roadworks were complete and SkyTrain is operational.

Staff advise that, on the south side of Lougheed Highway between Bell Avenue and Austin Avenue, a berm was implemented when the properties were initially developed to address the acoustic and visual effects of the Lougheed Highway. Even with this berm in place, the residents of Braemar Gardens have voiced concern about traffic noise from Lougheed Highway prior to the introduction of the Millennium SkyTrain Line. However, since the Lougheed Highway is an existing highway, the City had previously stated it would not be consistent with the existing policy to construct a noise attenuation barrier. As a result of this position the property manager for Braemar Gardens had previously made application to the City to undertake improvements to the berm at the expense of the Strata Corporation.

Staff noted that the recent road reconstruction work undertaken has had minimal impact on the existing berm adjacent to Braemar Gardens and would not likely have been responsible for any change in noise levels. Moreover, the eastbound travel lanes on Lougheed Highway were shifted about 1.5m further away (north) from Braemar Gardens as part of this recent road work.



In response to potential noise impacts associated with the operation of the SkyTrain, RTP 2000 Limited had installed guideway noise barriers along this section of the SkyTrain guideway. Staff advise that there appears to be no significant change in 24-hour noise levels regardless of source (road traffic or SkyTrain vehicles) based on the post-operation noise measurements undertaken while the Millennium Line is in full time operation.

The City Manager recommended:

1. THAT copies of this report be forwarded to Brian Suhner, Bayside Property Services Limited (Property Manager for Braemar Gardens), John Eastman, President, Rapid Transit Project 2000 Limited and Pat Jacobsen, Chief Executive Officer, TransLink.

Staff report that currently, the expansion of the Iron Workers' Memorial Bridge is not an element of TransLink's current Three Year Transportation and Financial Plan. Although it is on the list of projects up for consideration as an element of the TransLink's 10-Year Strategic Transportation Plan, the list is significantly oversubscribed and beyond the

combined current financial capacity of TransLink and MOT to deliver in total. The new Federal Canada Strategic Infrastructure Fund (CSIF) provides an opportunity for significant cost sharing from the Federal Government, up to 50 percent. As a result, the expansion of the Iron Workers' Memorial Bridge may prove to be a worthy CSIF project if its status as a regional priority can be confirmed with the participation of TransLink during the process of defining the scope of this potential CSIF project.

The City Manager recommended:

1. THAT Council request the District of North Vancouver to invite both TransLink and the Ministry of Transportation (MOT) to participate in this initiative.
2. THAT staff be authorized to participate in the early stages of this initiative to better assess the feasibility and advisability of developing a funding application to the Canada Strategic Infrastructure Fund to widen the Iron Workers' Memorial Bridge.
3. THAT Council forward copies of this report to Don H. Bell, Mayor, District of North Vancouver, Wayne Keiser, Acting Regional Director, South Coast Region, Ministry of Transportation and Mike Lai, Program Manager, Major Roads, TransLink.

The upper floor of the Alan Emmott Centre will be programmed and operated by the Parks, Recreation and Cultural Services Department. Probable uses include allotments to a small number of year-round community groups who would use the space two or three times per week, as well as offerings of departmental fitness/wellness programs. The upper floor will also be made available for private events such as weddings and banquets. It is anticipated that activities in the upper floor will commence in late 2002 or early 2003.

The lower floor has been leased to the Community-Centred College for the Retired (CCCR) for a five year period, as approved by Council at its meeting of 2002 October 21. The CCCR provides seniors with educational opportunities and, at present, offers thirty (30) courses, including such diverse topics as creative writing, bridge, piano and computer skills. The organization is agreeable to sharing one of the classrooms with other community groups on evenings, weekends and during the summer when it will not be using the space, and to sharing the office space and to sharing the office space with the Parks, Recreation and Cultural Services Department.
