#### CARRIED UNANIMOUSLY

A) Nikki Velasco, Reza Zolanvari, Taylan Alpiok and Liane Eng, Grade 12 Geography Students from Burnaby South Secondary School appeared before Council as a part of their studies of the environment and advised that they have conducted a survey regarding the installation of urban trails. The survey, which considered the views of 1800 participants, contained questions regarding the preference of urban trails, bikeways and cycle roads. In the public's view, the delegation noted that urban trails parallelling major roads will greatly increase cycling because of the perceived safety factors.

Councillor Corrigan arrived at the 'Open' Council meeting at 7:10 p.m. and took his place at the Council table

The delegation provided Council with a copy of the completed survey and an explanation of the results, including diagrams and the questions asked.

The speakers stressed the point that their goal was to address the needs of all types of cyclists from beginner to professional in both a recreation and transportation capacity. Furthermore, the speakers suggested that creating a truly functional cycling network for all ages and abilities would greatly enhance the livability of the City of Burnaby.

In concluding the presentation, the speakers stated that, in order to attain the goal of attracting more Burnaby residents to cycle instead of drive, we must educate the public about the benefits of cycling, at an early age. It is important that youth today understand the idea of living a better lifestyle with a safe, healthy and green alternative. With the availability of urban trails, cycling could extend the idea of being merely a recreational activity and instead, become a form of transportation for all ages.

**B)** Mr. Shawn Wade, President of the Burnaby Flatlands/Big Bend Neighbourhood Preservation Association appeared before Council accompanied by Mr. Ross Hepburn, Secretary of the Association to provide a response to the staff report dated 2002 March 20 regarding the Byrne Road/Marine Way Development Plan.

Mr. Wade discussed the use of agricultural land, suggestions on where to suitably locate big box development, traffic concerns in the Willard Street neighbourhood and solutions to satisfy all stakeholders. (The content of Mr. Wade's presentation was submitted in written form and is available in the City Clerk's Department.)

Mr. Ross Hepburn, 6056 Keith Street addressed Council for the purpose of discussing traffic issues in the subject area. Mr. Hepburn referred to the three-way stop at Gilley and Marine, suggesting that this is already a heavily congested intersection and, with the proposed opening of the 10<sup>th</sup> Avenue Connector, the situation will only worsen. Mr. Hepburn also cautioned that installing a traffic signal at this intersection will not solve the congestion problem but only create more gridlock. The speaker requested Council to carefully examine these traffic implications and consider better ways to introduce the proposed rezoning without creating any additional hardships.

Mr. Shawn Wade concluded his presentation by stressing that his community wishes to survive and continue its historic development pattern as a centre for rural excellence and a place where one can come to live in the country, yet still be near the City. Mr. Wade suggested that Council, by granting the community's request, will ensure that their community survives, that it thrives and that future generations can enjoy their life there. This action would also be an act of great statesmanship on the part of Council who yet again would show that they can balance off the interests of growth and development against those of local community neighbourhood survival and self-determination.

# A) Community Planning & Housing Committee Re: Armstrong and Monroe Avenue Area Rezoning

The Community Planning and Housing Committee submitted a report reviewing the results of the public consultation process regarding a proposed area rezoning of the 8800 - 8900 Blocks of Monroe Avenue and Armstrong Avenue to the R4 District. The Committee advises that of the 25 properties in the area, only 10 indicated support for the area rezoning and 10 indicated opposition. Therefore, the benchmark figure of fifty percent of all properties in support of the area rezoning was not reached. Accordingly, the Committee recommends that this rezoning request be denied.

The Community Planning and Housing Committee recommended:

- 1. THAT Council deny the request for an area rezoning of the 8800 8900 blocks of Monroe Avenue (south side) and Armstrong Avenue (north side) to the R4 District.
- 2. THAT the residents and property owners in the area proposed for rezoning be notified of Council's decision.

### 2. Proposed New Provincial Liquor Licensing System

The City Manager submitted a report from the Director Planning and Building providing Council with a preliminary report on recent and anticipated changes to the provincial liquor licensing system. The report highlights and comments on the most significant aspects of the proposed new liquor licensing system and it is expected that the proposed amendments will be passed by the Province by late 2002 June. The regulations implementing the new liquor licensing system will not take effect until later this year. The delay in implementation is intended to allow local governments to make adjustments to relevant policies and regulations, such as amendments to zoning bylaws which make reference to the existing liquor license classes, development of a business licensing system, and the development of a fee structure designed to recover costs associated with the review of license applications.

Staff advise that the issues of concern as outlined in the report, and in the Appendix 1 attached, regarding the proposed liquor licensing system are significant and it is unclear as to what extent local governments will be able to impose locally based criteria in the implementation of the new regulations to be enacted by the Province. As such, it is being recommended that the Province not adopt the applicable regulations without first providing local governments with adequate time to review the regulatory amendments in draft form prior to their adoption.

- 1. THAT the Mayor be requested to write the Solicitor General, the Honourable Rich Colman and the Minister of Competition, Science and Enterprise, the Honourable Rick Thorpe to request that:
  - a) the Province not adopt regulations implementing the new liquor licence system without first providing municipalities with adequate time to review the applicable regulations in draft form and provide input;
  - b) the preliminary areas of concern outlined in Section 2.0 and Appendix 1 of this report be addressed in the development of regulations relating to the Provincial liquor licensing system; and
  - c) the Provincial Government consult with the hospitality industry and the general public prior to the introduction of anticipated new legislation related to the provincial liquor licensing system.
- THAT Council be requested to forward copies of this report to Burnaby Members of the Legislative Assembly and the General Manager, Liquor Control and Licensing Branch, 1019 Wharf Street, Victoria, B.C. V8V 1X4.
