Additional Information: This work order provides funding for the ongoing program of minor repairs and adjustments in the sewer system to ensure continuity of service to residents. Sufficient General Revenue funds are available and these expenditures are included in the Sanitary Sewer Utility component of the 2002 - 2006 Capital Program.

60-08-043 Pavement Overlay - 2002 Program

Street & Lane Rehabilitation

\$2,086 Million

Additional Information: The City has an annual pavement overlay program to restore deteriorated asphalt surfaces and extend the useful life of the pavement. This form of treatment is an integral part of infrastructure renewal that protects the City's significant investment in the road network. Appearing elsewhere on this agenda is an item awarding Contract 2002-06: Supply and Installation of Machine Laid Asphaltic Concrete. This work order provides partial funding for the annual pavement rehabilitation program.

The Draft 2002-2006 Capital Program includes a provision of \$1.936 million for the annual pavement rehabilitation program, however, the required funding is \$2.086 million. The additional \$150,000 expenditure is fully funded by monies received from Translink for rehabilitation of MRN roads and will not impact the capital repayable limits.
