PURPOSE:

To provide a wrap-up report on the complete construction.

Recommendation:

1. THAT this report be received for information purposes.

REPORT

1.01 Background:

The Burnaby Lake Sports Complex-West was completed in the fall of 1999 with three (3) synthetic turf fields, field house and maintenance building. The original concept at that time planned for the future development of fields 4 and 5. In 2001 the Parks and Recreation Department requested an investigation be carried out to determine the feasibility of developing two (2) synthetic turf fields in place of the natural grass fields originally proposed during design in 1998. Due to the fact that the ground had not been prepared to accept synthetic turf fields the firm of Golder Associates was retained to undertake a detailed sub-surface investigation and provide the city with their recommendations. The results of this investigation concluded that synthetic fields could possibly be constructed if ground improvements were undertaken. Based on these findings and with the approval of the Civic Development Committee additional geotechnical work was undertaken by Thurber Engineering Ltd. to prepare tender documents for the preloading of the site to consolidate the soft underlying peat soils.

A tender call for the preloading of fields 4 and 5 was released on 2002 July 31 and closed on 2002 August 14. A contract was subsequently awarded to C.A.P. Ventures on 2002 August 26.

2.0 Construction Status:

The contractor C.A.P. Ventures Ltd. mobilized equipment and his forces on site in early September. On site work began with the installation of tree protection, siltation fencing, perimeter fencing and the relocation of the existing pathway and lights along Joe Sakic Way. By the end of September the stripping of the existing vegetative growth had been completed and the placement of preload material had begun. The entire preload placement was completed by mid-October 2002. Monitoring instruments placed during the preload operation will be checked on a regular basis by the geotechnical engineer over the next year.

3.0 <u>Conclusion</u>:

The preloading of fields 4 and 5 was undertaken and completed on time and within the established budget. The preload will remain in place for a minimum of one year or until the geotechnical engineer has determined that sufficient consolidation has occurred. The results of the ongoing monitoring and recommendations of the geotechnical engineer will be summarized in a future report to the Committee
