IN MEMORIAM

Acting Mayor Redman announced with sadness, the recent passing of Freeman William (Bill) John Copeland, former Mayor of Burnaby from 1987 to 1996. Acting Mayor Redman requested a moment of silence to remember one of the City's most loved heroes.

PROCLAMATIONS

Councillor Begin, on behalf of His Worship, Mayor Drummond proclaimed the week of 2002 September 14 to 22 as "Nikkei Week 125" in the City of Burnaby.

Councillor Corrigan, on behalf of His Worship, Mayor Drummond proclaimed 2002 September 14 as "South Burnaby Metro Club 50th Anniversary" in the City of Burnaby.

Councillor Harris, on behalf of His Worship, Mayor Drummond proclaimed the week of 2002 September 09 to 15 as "Terry Fox Week" in the City of Burnaby.

SEPTEMBER 11 - ONE YEAR LATER

On behalf of the City Council and the citizens of Burnaby, Acting Mayor Redman advised that the City of New York and those who died on 2001 September 11 will never be forgotten. That day will remain in everyone's hearts and minds forever as a tragic event. The impact was felt greatly by Canadians, as over \$25 million was given in donations by Canadians to the American Red Cross to provide financial assistance to families who lost a family member in the attack, to provide lodging for families evacuated from their homes and to feed the workers.

Acting Mayor Redman reminded Council that Burnaby became part of that response, when one of the City Employees, Debbie Clyne, was called into action as a Red Cross volunteer, twice. The day after the attacks, Debbie provided worker care at the Red Cross call centre - debriefing volunteers and staff who answered emotional phone calls from people inquiring about family and friends lost in the World Trade Center or wishing to donate money.

Debbie was then called to New York for three weeks to supervise volunteers at a Respite Center at Ground Zero - - a facility providing food, lodging, clothing, chiropractic, mental health, spiritual and first aid care for 8,000 workers a day who were digging on the pile.

To honour the memory of the victims and heroes killed in the September 11 World Trade Center attacks, Acting Mayor Redman advised that Burnaby firefighters will be holding a memorial service in each of the city's six fire halls. A brief ceremony at 6:45 a.m. will include a moment of silence and a recital of the firefighter's prayer.

On October 12, 40 to 50 Burnaby firefighters will be in New York to attend a special ceremony to honour the firefighters killed in the line of duty.

A) Mr. Roy Hunter appeared before Council as a 39 year resident of 3995 Kitchener Street. The purpose of his presentation was to advise Council of the constant problems he is experiencing with a business located at 3984 Kitchener Street, directly across the street from his home.

Mr. Hunter advised that the property at 3984 Kitchener Street has no lane access and is too small to accommodate a business the size of which is currently operating. The recycling and food vending company is in full operation 364 days a year, commencing at approximately 6:30 a.m. each morning and going on into the evening hours. The speaker complained of the constant truck traffic and vehicles parking in front of his property, even though there is a sign posted prohibiting parking.

The speaker also advised that he has been subjected to very derogatory and racist comments and has had threats against his person and property.

Mr. Hunter went on to advise that the subject business made application to the Board of Variance to construct a chain-link fence around the property to include a security device. The Board of Variance approved the appeal, second time around, and the fence is soon to be constructed and will include razor wire across the top. Mr. Hunter took exception to the Board's ruling and questioned how anyone could accept the ugliness of the proposed fencing with razor wire, directly in view from his front window. The speaker suggested that razor wire is only used at correctional institutions and should not be allowed in a residential neighbourhood.

In concluding his comments, Mr. Hunter urged Council to find a solution to the problems.

Arising from consideration of the delegation's presentation, Councillor Volkow was given leave by Council to introduce the following motion:

"THAT staff prepare a report responding to the comments and concerns raised by the delegation."

Arising from the discussion Council requested staff to provide a chronology of events regarding the subject business on Kitchener Street, questioned if Council has the authority to regulate hours of business and inquired if anything could be done about the proposed razor wire to be installed on the chain-link fence.

B) Mr. Brian Bonney, 8306 Government Road, Mr. Tom Heatherington, 3795 Eton Street and Mr. Corey Coyle, 4760 Gatenby Avenue appeared before Council to deliver a presentation on the future of Burnaby Lake.

The delegation presented Council with their proposed "Seven steps to a healthy lake" which includes:

- Curb sediment flows from Burnaby streets, storm sewers and large paved surfaces
- Seek help from Vancouver and the GVRD with sediment flows into Still Creek
- Work proactively with property owners to curb sediment flows where they originate on private lands
- Install sediment traps in feeder creeks
- Use suitable technology to oxygenate creek water
- Create a community partnership to develop a shared vision for a post-dredge Burnaby Lake and to help build and operate a replacement facility for the existing Burnaby Lake Pavilion
- Implement an environmentally responsible minimal dredging plan based on the City's Option 2.

In concluding their presentation, the delegation suggested they would allocate a cumulative \$21 million from the City's gaming funds towards elements of their proposed plan. It was suggested that drawing from this available funding source would expedite the process of saving the Lake as opposed to waiting for funding from other governments.

The re-paving of this section of Joffre is being funded through the 2002 pavement rehabilitation program which does not include additional facilities such as interim sidewalks. The 2002 funds for asphalt walks have been exhausted but provision of the proposed walkway will be introduced in the provisional 2003 Capital Program.

Brown Pool and Cameron Centre were closed for maintenance, Kensington Park outdoor pool was closed due to a water main leak. Eileen Daily Pool remained open. Staff will review the maintenance shutdown schedule to ensure that it results in a minimum of inconvenience to the public in the future.

Re: Noise from Anduccis Restaurant Patio

A letter was received from Wendy Hankin regarding noise from Anduccis Restaurant outdoor patio.

Since July 9th, Staff have monitored the use of Anducci's patio and reviewed the situation in light of this correspondence. Over this period, the restaurant has made considerable effort to comply with the regulations on the patio use. On occasion, the patio has been occupied beyond the 10:00 p.m. limitation. The writer reported three such occasions to staff. Despite these occurrences, staff feel the business is complying with the spirit of the regulations. Any negative impact of the occasional 'overtime' use of the patio appears to be isolated. Unless otherwise directed by Council, staff will discuss the matter with the writer and continue to monitor the situation.
