A) Bob Smith, President and CEO of the Fraser Health Authority and Gillian Harwood, Health Services Administrator for Burnaby appeared before Council to provide an update on the recent decision to relocate services from St. Mary's Hospital.

Mr. Smith advised that the proposal by the Fraser Health Authority is compatible with the spiritual intent and values of the Sisters of Providence and that the Sisters are directly involved in development of the continuity plan.

The speaker noted that since the announcement on November 03, the Fraser Health Authority has embarked on a wide scale consultation process with physicians and staff at the destination sites: Surrey Memorial; Burnaby General; Eagle Ridge Hospital; Royal Columbian; Queen's Park Care Centre and Royal City Manor.

The Hospice Unit at St. Mary's is now closed and new geriatric patients and subacute patients will be going to Queen's Park Care Center and Royal City Manor. However, St. Mary's will continue to perform day care surgery and inpatient surgery into the new year. Mr. Smith addressed concerns regarding increases to waiting lists because of the closure, stating that bringing additional services on stream at alternate facilities should alleviate these concerns.

The speaker noted that although lay-off notices have been issued to St. Mary's staff, these individuals are being recruited to other sites within the Fraser Health Authority and their applications are being fast tracked.

In conclusion, Mr. Smith advised Council that the Fraser Health Authority is committed to the most efficient and effective patient care standards available.

Councillor Redman retired from the Council meeting at 8:25 p.m.

Councillor Redman returned to the Council Chamber at 8:26 p.m. and took her place at the Council table.

Ms. Pamela Bhatti, 36 Grosvenor Street, Burnaby, B.C. appeared before Council to address the report of the Housing Committee for 00-100 Block Grosvenor Street. Ms. Bhatti suggested that the calculation of the Planning Department of 54% opposed to the area rezoning is incorrect as it included a non-response.

The delegation presented a map outlining the number of 33' frontage lots in the surrounding area. The speaker addressed concerns presented by the consultation area advising that the current duplex lots would be reduced to 2 single family dwellings keeping the density in the neighbourhood the same.

The speaker also expressed concerns about the scope of the consultation area stating that it should not have included the large lot area north of Cambridge Street as this area is zoned differently. In conclusion, Ms. Bhatti requested the Housing Committee reconsider this issue as the small lot proposal is not out of character with this neighbourhood.

Mr. Michael Veznavovic, 112 Grosvenor Street, requested Council allow the rezoning to proceed as it would not be out of character of the neighbourhood.
