PROPOSED CHANGES TO COMMITTEE STRUCTURE

<u>Civic Development Committee</u> <u>Finance and Economic Development Committee</u>

• It is recommended that the duties and responsibilities of the Finance and Economic Development Committee be merged with the Civic Development Committee.

Emergency Planning Committee

• It is recommended that the duties and responsibilities of the Emergency Planning Committee become the responsibility of the Executive Committee of Council. This recommendation is put forward recognizing that there is currently an in-house staff committee charged with the responsibility of emergency planning for the City. All reports and recommendations of the staff Committee will be forwarded directly to the Executive Committee of Council for consideration.

Bicycle Advisory Committee

• It is recommended that the Bicycle Advisory Committee, as an advisory body, meet with the Chair and Members of the Transportation Committee on a quarterly basis to discuss cycling related issues. All reports and related recommendations arising from such meetings will be submitted to Council by the Transportation Committee. Given Council's approval, a quarterly meeting schedule for the advisory committee will be arranged.

Family Court and Youth Justice Committee

• It is recommended that the Family Court and Youth Justice
Committee be disbanded, due to the recent closure of Burnaby's
Family and Youth Court. Any matters relating to family court and/or
youth justice will be referred to the Community Policing Committee.
Given Council's approval, the Mayor's Office will forward a letter to
the members of the Family Court and Youth Justice Committee
thanking them for their dedicated and valuable community service
and encouraging them to submit an application to serve on another
Committee of Council.

CONCLUSION

The purpose of this report is to appoint Council members to the various Boards, Committees and Commissions for a one year term and to streamline the current Committee structure. As noted in the report, I am recommending the merging of duties and responsibilities between some Committees and the elimination of the Emergency Planning Committee and the Family Court and Youth Justice Committee. The objective of this exercise is to continue to promote the efficient and effective way in which the Committees and Council work together but also takes into consideration the allocation of limited staff resources who liaise with Committees and facilitate Committee meetings.
