The Executive Committee of Council submitted a report arising from a presentation from Ms. Kathy Bonitz and Ms. Joy Parr at the Open Council meeting held on 2003 January 13, requesting that Council adopt the following resolution of support for the Romanow Commission recommendations.

"WHEREAS the Federal Government significantly reduced transfer payments to the provinces for health care and social programs in the early 1990s; and

WHEREAS many provincial governments have initiated their own restrictions to the health system, resulting in the de-listing of outpatient services, hospital closures, layoffs and tighter eligibility requirements for services such as home care and pharmacare; and WHEREAS municipalities, being the level of government closest to the people, have been hearing strong concerns from local residents about cuts to the health system and have faced increasing pressure to fill the resulting gaps through such means as funding of non-profit service providers and purchase of hospitals threatened with closure; and

WHEREAS, despite the challenges being faced, the Romanov Commission report revealed that the health outcomes of the Canadian system are amongst the best in the world and the majority of Canadians who use the system are satisfied with the quality and standards of care they receive;

THEREFORE BE IT RESOLVED that the City of Burnaby inform the Governments of Canada and British Columbia of its general support for the proposals of the Romanow Commission Report, believing they provide the framework for transforming medicare into a truly national, more comprehensive, sustainable, responsive and accountable system.

BE IT FURTHER RESOLVED that the City of Burnaby extends its support for the 2003 First Minister's Accord on Health Care Renewal and urges the Governments of Canada and British Columbia to continue to cooperate and devote sufficient resources to renew and sustain the Canadian health care system;

BE IT FURTHER RESOLVED that the City of Burnaby, while acknowledging the need for managing resources efficiently, expresses its strong concern to the Provincial Government and Fraser Health Authority regarding the short and long term implications of the extensive cuts being made to the health system - notably closure of hospitals and continuing care facilities, restriction of coverage for home care and pharmacare programs, and the trend towards staff layoffs and the privatization of services;

BE IT FURTHER RESOLVED that the City of Burnaby urges the Provincial Government and its respective Health Authorities to adopt a policy of meaningful consultation with municipalities on proposed changes to the health system, ensuring that the full impacts on local residents and municipal governments are carefully considered before changes - particularly negative changes - are introduced; and

BE IT FURTHER RESOLVED that the City of Burnaby requests the Lower Mainland Municipal Association to adopt a resolution similar to the one contained herein, advancing it for endorsement by the Union of BC Municipalities."

Accordingly, the report did not recommend any change to the current stopping prohibition.

5. **NEW BUSINESS**

Councillor Volkow

Councillor Volkow advised Council of a grant request from the Burnaby South Senior Improv Team who recently won a berth at the National Improv Championships in Ottawa, Ontario in 2003 April. Councillor Volkow advised that since 1986, Burnaby South students have participated in the Canadian Improv Games and thousands of students, parents, enthusiasts and teachers throughout the Lower Mainland have witnessed their remarkable, high-energy performances.

For several of the Team's members, a chance to compete in the National Championship is the fulfilment of a dream they have nurtured for the past four years. Members of the Team, their families and their coach are committed to finding the financial means to help them realize this ambition.

Councillor Volkow advised that, since the Executive Committee of Council is not scheduled to meet until 2003 April 14, he would like to bring forward a motion supporting the grant request.

His Worship, Mayor D.R. Corrigan, in the absence of the Acting Mayor, appointed Councillor Johnston to assume the Chair as Acting Mayor.

His Worship, Mayor Corrigan retired from the Council Chamber at 8:41 p.m. advising that a family member is a performer of the Burnaby South Senior Improv Team.

"THAT staff investigate and report on the advisability and feasibility of an amber alert system to assist when children go missing throughout the Lower Mainland."
