A) Mr. John Butterworth, 4108 Winnifred Street, Burnaby, B.C. appeared before Council to discuss the proposed redevelopment of the New Haven site at 4250 Marine Drive.

Mr. Butterworth inquired about the Glen Lyon Connector and whether it is still planned to connect Marine Way and Patterson. The speaker also questioned the December 12 deadline for submission of public comment as it is earlier than anticipated. Mr. Butterworth requested the deadline be extended to mid-January.

The speaker referred to a brochure distributed to affected residents and expressed concern that the only question in the brochure asked residents to choose Option 'A' or Option 'B'. Mr. Butterworth then outlined several questions he suggested should be part of an area questionnaire.

Mr. Butterworth stated that the increase in traffic should be dealt with by the City; there should be pedestrian access improvements at Riverway School and playground improvements at the School as part of this project. He expressed opposition to the inclusion of industrial/commercial development in the project. In addition, he noted he would only support single family residential development on the north lot; not multifamily development.

The speaker suggested that the southern lot should be included in the Agricultural Land Reserve.

In conclusion, the speaker requested the deadline for submission of public comment be extended to the end of January; the Planning Department to approach the Agricultural Land Commission to include the south lot in the ALR; and that the development enhance the livability of the area for its residents.
