1. Drug and Alcohol Recovery Services

The City Manager submitted a report from the Director Planning and Building responding to Council's request for information on issues facing Charlford House Society for Women and addictions treatment services in the Fraser Health Authority (FHA).

These issues were raised as a result of correspondence received at the 2003 January 13 Council meeting from Linda Shaw, Program Director at Charlford House, which cited several concerns regarding changes in the FHA's funding and policies for addiction services and a delegation from Rock Chalifour, Registered Nurse, Royal Columbian Hospital speaking to Council at the 2003 January 20 meeting on behalf of the Addiction Treatment Advocacy (ATA) Group. Mr. Chalifour described the seriousness of addiction issues in the region and expressed strong concerns about recent FHA funding cuts for addiction treatment.

Staff reported that for the past decade or so the addiction treatment system in B.C. has been in considerable flux as it has moved amongst various Provincial ministries and, since 2002, has come under the auspices of regional health authorities. Short falls in funding allocations for addiction treatment services continue to challenge service providers as they struggle to meet the high demand for services.

The City Manager submitted a report from the Director Planning and Building requesting Council approval to forward this application to a Public Hearing on 2003 March 18. The purpose of the proposed zoning bylaw amendment is to permit a low-rise multi-family development.

The City Manager recommended:

All services are to be designed to City standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
 - c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.

- d) The submission of an undertaking to remove all existing improvements from the site within six months of the rezoning being effected but not prior to Third Reading of the Bylaw. In the event that existing improvements on the site are vacant and considered to be unsafe, unstable and a hazard to life, the Fire Prevention Division may recommend immediate demolition of such improvements and removal of the resultant debris prior to Third Reading.
- e) The consolidation of the net site into one legal parcel.
- f) The granting of any necessary easements and covenants, including, but not necessarily limited to, Section 219 Covenants restricting the enclosure of balconies and indicating that eight ground level units will be provided with universal design elements as prescribed by the City of Burnaby.
- g) The dedication of any rights-of-way deemed requisite.
- h) The undergrounding of existing overhead wiring abutting the site.
- i) Compliance with Council-adopted sound criteria.
- j) The provision of a covered car wash stall and an adequately sized and appropriately located garbage handling and recycling material holding space within the underground parking and a commitment to implement the recycling provisions.
- k) The deposit of the applicable GVS & DD Sewerage Charge.
