A) Mr. Vic Blancard, 4630 Highlawn Drive, Burnaby, B.C. appeared before Council to discuss issues of taxation in Burnaby affecting seniors, the unemployed and those on fixed income. Mr. Blancard expressed concerns as the large increases in property values do not translate into increased income available to seniors. The speaker suggested the use of the City's contingency fund and gaming revenues as alternatives to raising property taxes.

In conclusion, Mr. Blancard requested Council extend the ten minute limit on delegation presentations.

B) Mr. Peter Hanson, appeared before Council to discuss access and services in Burnaby for persons with disabilities.

Mr. Hanson referred to the closure of the Super Valu at Middlegate Mall and problems with access to the site as a result of the current construction. He noted that there is no parking at the mall itself and no easy access for persons in wheelchairs which is creating a safety hazard for citizens.

The delegation further discussed the handicapped access to City Hall and the location of handicapped parking spots at Metrotown Mall. Mr. Hanson referred to policies in the United States which allow anyone with a handicapped parking decal to park for free at any on-street metered parking spot and requested that Council consider implementing the same program in Burnaby. The speaker inquired as to why the Super Valu at Middlegate Mall was closed ahead of schedule.

Council requested that staff look into the matter of wheelchair accessibility during the construction period at Middlegate Mall.

**C) Ms. Bertha Schmidt**, 903 - 4350 Beresford Street, Burnaby, appeared before Council to discuss the issue of leaky condominiums and responsibility for this problem.

Ms. Schmidt advised the value of her residence has been affected by the leaky condo crisis. The property tax assessment for her building has increased even though the property is in a state of disrepair. The speaker requested the City do what it can with all new construction to prevent losses resulting from leaky condos.

Council advised that a review of this matter is currently being undertaken by the City of Burnaby.
