A) Mr. Brian Simpson, Branch No. 148, Mr. Tom Stewart, Branch No. 83 and Mr. Daryl Whiting, Branch No. 44 appeared before Council on behalf of their Royal Canadian Legion Branches and were presented with a *Poppy Week* proclamation from His Worship, Mayor Derek R. Corrigan. Mayor Corrigan announced that in addition to the list of speakers on the Council agenda the following members were also in attendance at the meeting: representing Branch #83 - George Bernett, John Otway, Tom Stewart, Stein Bergrud and Tom Wadell; and representing Branch #44 - Daryl Whiting.

Mr. Tom Stewart thanked Council and the Community Heritage Commission with regard to the rededication of the cenotaph which will take place on Wednesday, 2004 November 10th at 1:00 p.m. The ceremony will be held at Southoaks, in front of the memorial tennis courts. The cenotaph honours the memory of 51 former students of Burnaby South High School who lost their lives serving in the armed forces during World War II. The speaker noted that there was concern nothing was known about the individuals named at the cenotaph so over the last three years, the South Burnaby High School and City staff have researched each of the 51 names and now know rank, branch of service and where each individual was killed and buried. Mr. Stewart advised that this information will be given to Council at the rededication and will be available at Alan Emmott Centre.

Mr. Simpson reminded Council that it is again the time of year to remember the sacrifices made by those who have fought in or lived through all the wars and conflicts in which Canada has participated.

Mr. Simpson also informed Council that the approximate \$30,000 raised last year during Poppy Week went towards supporting organizations for the elderly with representation of veterans including Burnaby General Hospital, George Derby Hospital, Meals on Wheels and Confederation Senior's Park. The speaker concluded by inviting everyone to come out and join in on the Remembrance Day celebrations. It was noted that Branch #44, T.V. Section is located at 4050 Graveley Street.

The Legion members presented poppies to staff and the members of Council. His Worship, Mayor Derek R. Corrigan thanked the members of the Legion for the honour of their presence at the meeting and encouraged residents of Burnaby to support Poppy Week.

B) Ms. Joan Carne, Chair, Byrne Creek Streamkeepers appeared before Council to share the results of their First Annual Status of the Watershed report. The speaker provided highlights from the report in a visual presentation.

Byrne Creek is located in south Burnaby and most of the rain which falls on the south side of Kingsway drains into the Creek. The speaker identified and reviewed the following watershed health indicators: the spawners; resident fish; sedimentation and erosion; bug survey; discharge measurements; invasive plants and streamkeepers.

The streamkeepers are currently involved with counting the fish which are spawning. Ms. Carne advised that the numbers of fish seem to be increasing and that efforts by the streamkeepers and the City appear to be having a positive affect.

Of these, a Special First Nations Electoral Area appears to be the most viable option in that it provides both a First Nation representative on the GVRD Board and limits potential proliferation of new members.
