Nicole Alvi, student and team member noted this was the first time South Slope Elementary School has competed in the Odyssey of the Mind and won the Provincial Championship.

Chris McClelland, student and team member advised 2004 is the 20th Anniversary of Odyssey of the Mind - a competition that promotes creative problem solving and team work.

Dimitri Lennikov, student and team member advised that in the competition 5 problems are presented and the teams choose one to solve. The South Slope Team developed an *"Envirover"* - a human powered 3 wheeled vehicle to pick up garbage and deliver products they developed themselves. The competition included a humorous sales pitch.

Nicole Alvi advised the *"Envirover"* was made out of recycling bins and it won the award for outstanding creativity.
