Northeast Sector Rapid Transit Project

Mayor Scott Young, City of Port Coquitlam and Mr. Glen Leiceister, Vice President of Planning, TransLink, appeared before Council to present the findings of their recent technical visits of European Light Rail Transit Systems.

Transportation Systems in France including Strasbourg, Caen and Paris and London, England were reviewed by a delegation representing TransLink. Members of the delegation included Mayor Scott Young, Mayor Jon Kingsbury, Glen Leicester and Bob Gavin of the Citizen's Committee.

The delegation provided a detailed summary of each City's system. In conclusion, Mayor Young outlined a series of recommendations based on the corridor and alignment, technology and the next steps for presentation to TransLink.

- A) **Tony Barucci**, 3176 E. 15th Avenue, Vancouver appeared before Council to discuss his application to rezone property at 7450 Lowland Drive, Burnaby. The speaker advised that he would like to make the warehouse unit the headquarters for his coffee business as well as establishing a cappuccino bar at this location.

Mr. Barucci advised that through a petition circulated in the neighbourhood, he has determined there is strong support from businesses in the area for the cappuccino bar services as well as lunch service. The speaker described the many different businesses in the area, estimating that at any given time there are 5,000 - 7,000 people in the neighbourhood.

Mr. Alex Durant, Quality Control Manager, Data Networking, a local business representative appeared before Council to express support for the rezoning application. He noted there are limited food vendor opportunities in the area and an additional business of this type would be very welcome.

- B) Gail Reid, Burnaby Claims Centre Manager and Gord Couling, ICBC Regional Coordinator, Burnaby Loss Prevention & Road Safety** appeared before Council to express appreciation for the proclamation of Pedestrian Safety Month in the City of Burnaby.

Ms. Reid advised the 2004 Campaign began with the return to school and a particular focus on elementary schools. All schools in Burnaby were provided with yellow *'Please Slow Down'* signs. Mr. Couling advised the second phase of *'Be Safe Be Seen'* campaign will begin on Tuesday, 2004 October 05 and will target vulnerable road users.

The speaker noted that on average six pedestrians per day are injured on B.C. roads. He advised that the *'Be Safe Be Seen'* campaign encourages these simple steps to be safe on B.C. roadways: wear bright clothing; use designated crosswalks, always stop, look and listen; be sure and expect the unexpected.

Councillor Volkow retired from the Council Chamber at 8:06 p.m.

Phase two of the *'Be Safe Be Seen'* program will run through 2004 October 31. ICBC is making available to the public at no charge reflective Halloween trick or treat bags. The bags will be available at various locations including Burnaby City Hall.

Councillor Volkow returned to the Council Chamber at 8:10 p.m. and took his place at the Council table.

His Worship Mayor Derek R. Corrigan advised that Bonney Rempel, Marketing Director of Lougheed Town Centre has been awarded an International Council of Shopping Centres Maple in Toronto this past summer for the community entry *"Live & Let Live"*. The Maple is the highest recognition a Shopping Centre Marketing Director can achieve. Again, in San Antonio, Texas on September 29th, the *"Live & Let Live"* project won a prestigious *"2004 Maxi Award for Marketing Excellence"*. The *"Live & Let Live"* project is a community endeavour to foster a meaningful dialogue among all school age youth, parents, civic officials and community stakeholders on the underlying causes and heart-rendering effects of the premature death of our youth during the opportune weeks leading up to secondary school graduation ceremonies. Bonney Rempel, the Marketing Director of Lougheed Town Centre spearheaded this project on behalf of Lougheed Town Centre.

On behalf of Council and the citizens of Burnaby His Worship Mayor Derek R. Corrigan congratulated Lougheed Town Centre, Bonny Rempel and everyone in the community who participated in this very worthwhile project.




