1. THAT Council adopt the attached resolution supporting the B.C. Nurses' Union Patient Bill of Rights.

### REPORT

Council, at the 'Open' Council Meeting held on 2003 June 14, received a presentation from Ms. Kathy Bonitz and Ms. Melanie Leckovic requesting endorsement of a resolution supporting the BCNU Patient Bill of Rights. This document proposes significant improvements to the health care system. Suggested improvements fall under the following headings: Access to Hospital Services; Access to Community Services; Access to Senior's Care and Access to Information. Arising from discussion, Council referred the BCNU request to the Executive Committee of Council for consideration.

The Executive Committee of Council, at its 'Open' meeting held on 2004 September 27, received and adopted the attached resolution supporting the nurses Patient Bill of Rights and urging the provincial and federal governments to work with the public, the City of Burnaby and health care providers to develop an implementation plan to improve the health care system in B.C.
