A) Mr. Nathan Woods, representing the Canadian Autoworkers Local 111 Burnaby Transit Centre Property accompanied by Mr. Randy Gorman also of Canadian Autoworkers Local 111 appeared before Council to address concerns of the CAW

0

Local 111 with respect to recent events involving the approval process for transit planning in the City of Burnaby. The speaker contends the approval processes for transit routings do not grant an adequate opportunity for City residents, Coast Mountain Bus Company, frontline workers, elected Health and Safety and Service Review Committee representatives and the CAW Local 111 to be involved in the construction of service implementation and route changes.

Mr. Woods requested the City of Burnaby implement a process whereby all parties are documented as having expressed their positions before approving service implementation.

In conclusion, the speaker requested the City of Burnaby demand TransLink and the Coast Mountain Bus Company implement a public consultation process based on TransLink's Annual Service Plan, beginning with discussions between Coast Mountain Bus Company and Canadian Autoworkers Local 111 members, proceeding to resident open houses, from open houses to Burnaby's Transportation Committee and finally to Burnaby Council for approval.

B) Mr. Keith Pinchin, 7110 Patterson Avenue, Burnaby, B.C. appeared before Council with concerns about the future of Patterson Avenue, between Imperial Street and Marine Drive.

The text of the delegation's presentation is provided as follows:

"Over the past two years we feel that proposed changes have threatened our Avenue. On 2004 March 01 after considerable community opposition and a 1000 signature petition, City Council adopted a finalized Framework Plan for the New Haven property excluding a through-road connecting the Glenlyon Parkway Avenue at Marine Drive. We thank the Mayor, Council and Housing Committee for this.

Recently, the proposed rerouting of the #116 bus route has also met with considerable community opposition. The intent of this route, clearly described in a Coast Mountain Bus Company handout obtained in 2005 May, is to provide better conventional (big bus) "commuter" service between Metrotown and the Glenlyon Business Park. After delivering at least 94 letters to City Council and presenting the Transportation Committee a petition of 173 signatures opposing the #116 conventional (big bus) service on Patterson Avenue, the Committee Report regarding "Bus Route Changes in South Slope/Big Bend Area" was sent back to staff for further review. We would like to thank the Transportation Committee for hearing our concerns on 2005 June 22. Copies of our presentation are to be distributed to all Council members by the City Clerk with the amended Staff Report when available.

#### 2005 July 11

We do not support any changes that will inflict excessive noise and pollution from heavy vehicle traffic on residents. We understand that traffic volumes on Patterson Avenue will increase as our City grows. We accept this increased traffic providing the City install and maintain safety and calming measures and necessary signs to ensure our avenue continues to be safe and liveable as a "Major Collector Secondary" road. At the 2005 June 7 Traffic Safety Committee meeting we requested such improvements and don't feel it is unreasonable to expect safety and liveability on our street and we would welcome the opportunity to actively participate as a community in any planning.

We support the use of "neighbourhood friendly" Community Shuttles. It is our understanding, however, that once Coast Mountain Bus Company has been given approval to use a street for transit service, they no longer require the City's permission to add or change service (i.e. the type of bus that runs on that street). Given this, we are concerned that approval of the Community Shuttle service on Patterson Avenue will "leave the door open" for Coast Mountain Bus Co. to accomplish what they originally set out to do (run conventional big bus commuter service up and down our Avenue) in the face of substantial public opposition.

We request that Mayor and Council not support the use of Patterson Avenue as a conduit for big bus service, so clearly intended for shuttling Glenlyon employees commuting between Metrotown Skytrain/Bus Loop and their place of work. We also request that should approval be given for Community Shuttle service to run on Patterson Avenue, between Imperial and Marine Drive, that a commitment be given to the community by Coast Mountain Bus Co. and the City of Burnaby assuring public consultation on the affected route and Council approval be necessary before changing the type of bus running on this route.

Having been here two years ago opposing the Glenlyon Extension through the New Haven Property and now with the proposed #116 Commuter Bus, we hope the City Planners and Council recognize that residents of the Patterson Avenue corridor are concerned about our community and will continue to speak out against plans that will negatively affect our neighbourhood."

C) Ms. Angela Sealy, 6750 Station Hill Court, Burnaby, B.C. appeared before Council to express opposition to the use of noisy lawn equipment in Burnaby.

Specifically, Ms. Sealy is concerned about the use of gas and electric lawn mowers, weed whackers, edgers and leaf blowers.

The speaker is requesting Council prohibit the use of this equipment in residential areas of Burnaby.

A staff noted appended to the correspondence from the delegation advise the Burnaby Noise or Sound Abatement Bylaw restricts the use of power lawn mower of power gardening tools to the following hours:
