Arising from consideration of the request, Councillor Volkow was granted leave by Council to introduce the following motion:

"THAT a grant in the amount of \$1,000 be awarded to the 2005 Annual Labour Community Christmas Dinner."

Councillor Volkow noted that Burnaby resident Christine Sinclair has been recognized yet again for her skilled play on the soccer field as she has been short listed for the 2005 FIFA World Player of the Year award.

Councillor Rankin was granted leave by Council to introduce the following motion:

"THAT Burnaby Council ask the Federal Party leaders whether they would work to support the early implementation of legislation to amend the Criminal Code to raise the age of consent for sexual activity to age 16 from age 14 and further THAT Burnaby Council ask all Federal candidates in the Burnaby/Douglas and Burnaby/New Westminster ridings whether they support and will work for the implementation of such legislation."

### CARRIED UNANIMOUSLY

Council noted that the "close in age" provision should be included.

#### **Councillor Jordan**

Councillor Jordan referred to a memo Council received from the City Solicitor in response to the concerns of Burnaby resident, Mr. G. Salisbury, which have been raised regarding the City's Tree Bylaw and was granted leave by Council to introduce the following motion:

# MOVED BY COUNCILLOR JORDAN: SECONDED BY COUNCILLOR RANKIN:

"THAT an invitation be extended to Mr. Salisbury to attend an upcoming Community Development Committee meeting."

#### 6. INQUIRIES

### Councillor Begin

Councillor Begin inquired as to what the City of Burnaby is doing in response to the issue of homelessness, currently and for the future. The Director Planning & Building provided an update on the Extreme Weather Shelter process, which is

currently being reviewed by the Burnaby Homeless Task Force including the Lookout Society, the Salvation Army, the Fraser Health Authority as well as City staff. He advised that a meeting of the Task Force should take place within the next 10 days and in the meantime individuals are being referred to a temporary shelter in New Westminster. Council requested staff provide information and contact phone numbers for Emergency Social Services.

Councillor Begin inquired as to whether or not the City was still making an annual donation of \$2,000 to the Foodbank, which would be matched by a contribution from Safeway. It was concluded that the City has not been approached in recent years, however, Mayor Corrigan noted that the City has been working mostly with the Burnaby Christmas Bureau as the main distribution point.
