Mr. John Rielly, B.E.M. Fireworks Canada West appeared before Council to discuss recent changes appearing in the lower mainland regarding the sale and discharge of family fireworks.

Mr. Reilly advised that his company has recently surveyed several fire and rescue services within the GVRD to better understand the concerns of local governments.

As a result of the information obtained through the survey, the speaker is recommending development of a common bylaw throughout the GVRD to ensure fireworks are treated equally in all municipalities.

Mr. Reilly presented a copy of a draft bylaw for council's consideration.

In conclusion, Mr. Reilly recommended that "nuisance fireworks" be removed from individual retail sales and that they only be sold in limited numbers as part of a more expensive fireworks kit. He also recommended that a bylaw be enacted common to all municipalities, to address concerns regarding the proliferation of retail sales outlets for fireworks, effectively "bringing back the family into family fireworks," for those aged 18 and older.

1. Rezoning Reference #03-51 Costco Development Proposal: Restaurant and Auto Mall / Business Centre

The City Manager submitted a report from the Director Planning and Building requesting Council approval to forward this application to a Public Hearing on 2005 September 20. The purpose of the proposed rezoning bylaw amendment is to:

- to permit warehouse wholesale/retail, gas bar and office development on Lot 1 (see attached Sketch #1);
- to establish community plan guidelines for future restaurant development on Lot 2, subject to amendment rezoning based on a specific plan of development;
- to establish community plan guidelines for future auto-mall development on Lot 3 specifically to accommodate the relocation of existing new car dealerships in the Brentwood Town Centre, subject to amendment rezoning(s) based on specific plans of development;
- to establish community plan guidelines for Lot 4 to permit new car dealerships, flagship Harley Davidson motorcycle dealership with museum, and M5 type business centre uses, subject to amendment rezoning(s) based on specific plans of development:
- to affirm the designation of Lot 5 for City works yard use;
- to protect Lot 6 as a conservation area.

The City Manager recommended:

- 1. THAT the introduction of a Highway Closure Bylaw be authorized according to the terms outlined in Section 3.10 of this report, contingent upon the granting by Council of Second Reading of the subject Rezoning Bylaw.
- THAT the sale of City-owned property be approved in principle for inclusion within the subject development site as outlined in Section 3.11 of this report, and subject to the applicant pursuing the rezoning proposal to completion.

 - c. The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - d. The submission of an undertaking to remove all existing improvements from the site within six months of the rezoning being effected but not prior to Third Reading of the Bylaw. In the event that existing improvements on the site are vacant and considered to be unsafe, unstable, and a hazard to life, the Fire Prevention Division may recommend immediate demolition of such improvements and removal of the resultant debris prior to Third Reading.
 - e. The completion of a subdivision creating six legal parcels.
 - f. The granting of any necessary statutory rights-of-way, easements, and covenants.
 - g. The dedication of any rights-of-way deemed requisite.
 - h. The undergrounding of specified overhead wiring abutting and within the site.
 - i. The approval of the Ministry of Transportation to the rezoning application.
 - j. The deposit of the applicable GVS & DD Sewerage Charge.
 - k. The provision of facilities for cyclists in accordance with Section4.1 of the rezoning report.
 - I. The completion of the sale of city property.

- m. Fisheries authorization from DFO and deposit of bonding for all works in and around watercourses.
- n. Compliance with environmental requirements related to DFO, and Environment Canada, and conditions outlined in Notifications of Environmental Review Committee Decisions.
