ANNOUNCE MENTS

His Worship Mayor Derek R. Corrigan announced that the Canadian Parks Recreation Association (CPRA) recently presented the City of Burnaby with the *CPRA Award of Excellence in Innovation* for Burnaby's eco-sculpture program. The program began in 2004 with Parsely, a replica of a carousel horse and since that time has grown to include three salmon and two cranes.

Mayor Corrigan advised that the City's horticulture staff have acquired the skills and expertise in this horticultural technique, have developed the artistic talent needed to create the sculptures, have explored and experimented with plant species that work in the Western Canadian climate, have worked with local landscape and garden industry to promote the program and have offered training programs to educate other communities in developing their own eco-sculpture programs.

His Worship Mayor Derek R. Corrigan drew Council's attention to a photograph in the Council Chamber displaying a wood sculpture of a bear. The bear sculpture, based on the Playground of the Gods work created by Toku Nobori and situated on Burnaby Mountain, is to be given as a gift to Burnaby's Sister City of Mesa, Arizona in recognition of their new Arts Centre.

A) Brian Simpson, Chairman, 2005 Poppy Fund Campaign, Royal Canadian Legion Branch No. 148 appeared before Council to present information to Council about the charitable activities of the Royal Canadian Legion in Burnaby, the Lower Mainland and the BC/Yukon Region. The year's highlights for Branch No. 148 included substantial donations to many charities supporting veterans and their families such as hospitals and seniors services. Regionally, the Legion provided funds for low rental housing, hospital equipment, youth activities and others with total contributions of \$3.25 million.

In conclusion, the speaker expressed appreciation to Council for their support: past; present and future. Mr. Simpson and other members of the Legion then presented poppies to Council and those in attendance at the Council meeting.

The 'Open' Council meeting convened at 7:35 p.m. with Councillors Johnston, Jordan and Redman absent.

B) Bim Singh, 5058 Irmin Street, Burnaby accompanied by his real estate agent, Bill McGorgan appeared before Council to discuss the rezoning application for properties at 7438 and 7462 Royal Oak Avenue.

Councillor Johnston returned to the Council Chamber at 7:36 p.m. and took his place at the Council table.

Councillors Jordan and Redman returned to the Council Chamber at 7:37 p.m. and took their places at the Council table.

Mr. Singh discussed the value of property in the area and in particular, the property owned by Mr. Englund. The speaker advised that his most recent offer made 2005 October 20 was for \$707,000 and Mr. Englund countered with \$895,000. Mr. Singh noted the counter offer was more than the property was worth.

Mr. Singh provided an historical overview of the valuations of Mr. Englund's property and also advised that, in his opinion, Mr. Englund has no intention of ever selling his property. Mr. McGorgan confirmed that full value offers have been made to Mr. Englund on three separate occasions only to have them refused and the selling price of the property raised. Therefore, they can only conclude Mr. Englund is not serious about selling his property.

C) Sy Rodgers, 306 Mariner Way, Coquitlam appeared before Council to seek support to help save the YMCA's Camp Howdy located on 75 acres with ocean frontage in Belcarra. Camp Howdy provides one week and day camp experiences for children from the Lower Mainland, many of whom have devastating illnesses, disabilities or come from disadvantaged families.

As the YMCA is currently in need of funds to maintain its existing camps and to fund new projects they are contemplating selling the camp. There is currently a proposal on the table in which 39.8 acres (including waterfront)would be donated to the Greater Vancouver Regional District (GVRD) along with a guarantee to keep the camp open for 30 more years in exchange for a road allowance. The GVRD has accepted this proposal, however, Port Moody must also agree to a road allowance. At the last vote Port Moody Council turned down the YMCA. In response to the apparent demise of the camp, Mr. Rodgers and his wife began raising public awareness about this issue and circulated a petition to save the camp.

On 2005 October 11, Port Moody Council discussed the large public response in favour of maintaining the camp and delayed their decision for three weeks. The speaker advised Port Moody has stated publicly that they are now in full support of keeping Camp Howdy open.

In conclusion, Mr. Rodgers requested Council support Port Moody in their decision to accept the proposal and keep Camp Howdy operational.
