SUBJECT:

PARKLAND ACQUISITION LEVY EXPENDITURES

PURPOSE:

To provide funding from the Parkland Acquisition Levy Reserve for future

parkland acquisitions.

RECOMMENDATION:

1. **THAT** a bylaw be brought forward to appropriate \$5,000,000 from the Parkland Acquisition Levy Reserve to fund future land acquisition expenditures.

REPORT

In order to have funds available to pay for lands acquired for parks and recreation purposes, the Local Government Act requires that a bylaw be passed to appropriate funds from the Parkland Acquisition Levy Reserve.

This report accounts for the acquisitions made since the last report to Council on 2001 July 09, and recommends the appropriation of five million dollars. The unappropriated balance of the Parkland Acquisition Levy Reserve after the adoption of this bylaw would be \$19,254,734.
