PURPOSE:

activities for the fourth quarter of 2004.

# **REPORT**

During the fourth quarter of 2004 this department responded to 3,387 incidents.

#### 1.0 FIRES

Thirty-six fire investigations were completed during the fourth quarter with losses totaling an estimated \$544,169. They were due to the following act or omission:

# 2.0 TRAINING DIVISION

During the fourth quarter a six week class for five new members and three of our Fire Prevention inspectors took place. The course concluded with two days of live fire at the Fire and Safety Training Centre in Maple Ridge.

General training was scheduled to coordinate with the recruit class training. In October four members attended a Fast Response Boat Operator Training course while one member attended a three week Rope Rescue training course with ROCO Canada.

During November and December, eight First Responder Level III re-licencing classes took place as well as two CPR Instructor workshops and two Occupational First Aid classes.

HazMat crews on each shift at Station 5 attended the Chevron Refinery and Ballard Power for scene tours/hazard surveys during this quarter. They also had a member of the RCMP drug enforcement squad visit the station for a discussion on clandestine drug labs and marijuana grow operations.

#### 3.0 FIRE PREVENTION DIVISION

During the fourth quarter the Fire Prevention Division purchased a 3M belt-mounted, powered air purifying respirator and a 5,000 watt generator, two digital cameras and other miscellaneous fire investigation equipment.

Staff spoke to BCIT students on the subject of smoke alarms and attended the Fire Prevention Week booth and activities at Lougheed Mall.

Suppression crews received training from Fire Prevention Captains in fire investigation, sprinkler systems and fire alarm systems/elevators. Division Captains attended a one-half day seminar on evidence and statement taking for fire investigation. All Division staff attended Microsoft 2003 computer upgrade training during the quarter as well as a "Respectful Workplace" workshop.
