SUBJECT:

ABANDONMENT OF INACTIVE REZONING BYLAWS

**PURPOSE:** 

To put forward a number of rezoning amendment bylaws to Council for approval

to abandon in accordance with adopted Council policy.

## **RECOMMENDATION:**

**1. THAT** Council authorize the abandonment of the outstanding Bylaws listed in Appendix A of this report.

## REPORT

In accordance with established Council policy, this report is being submitted in order to seek Council approval to abandon outstanding, incomplete rezoning amendment bylaws. In order to identify bylaws for abandonment, staff wrote to the rezoning applicants and to applicable current owners of rezoning applications that were not being actively pursued. Letters advised that unless progress could be demonstrated in satisfying the prerequisite conditions, their specific application would be included in a list of rezonings to be recommended for abandonment by Council. Staff also wrote to applicants of rezonings which have been inactive and had not previously reached the bylaw stage.

In response to the above noted letters, several applicants or owners expressed a desire to keep specific rezonings active. In such instances, the rezoning has not been included in this report. Appendix A (<u>attached</u>) contains a list of all the rezoning amendment bylaws which are recommended to be abandoned in accordance with adopted Council policy. The list also includes bylaws which have been superseded by other rezoning bylaws which were subsequently advanced and given readings. Staff will also complete the administrative process to close those inactive files which had not reached the bylaw stage.

It is recommended that the rezoning amendment bylaws outlined in Appendix A be abandoned.
