Councillor Volkow commended the Portuguese Canadian Seniors Foundation on their new facility as it is a great addition to the community.

Councillor Begin advised he had recently attended a Vancouver Symphony Orchestra reception where they talked about the endowment fund and how the Provincial and Federal governments match the endowment fund dollar for dollar. Councillor Begin inquired as to whether the City of Burnaby has considered establishing an endowment fund for a community purpose, perhaps by using gaming revenues, in order to capture the Provincial and Federal funding.

His Worship Mayor Corrigan described the Burnaby Solution which was a resolution that had been brought forward to the GVRD and recommended funding for cultural institutions on a regional basis. The fund was established through the GVRD. Mayor Corrigan noted that the idea of a Burnaby Foundation is still under consideration.

Arising from consideration of the matter, Councillor Begin was granted leave by Council to introduce the following motion:
