His Worship Mayor Derek R. Corrigan, proclaimed 2006 September 21 as "International Day of Peace" in the City of Burnaby.

His Worship Mayor D.R. Corrigan announced that Councillor Calendino had been presented with an Award of Distinction by his home Province of Calabria on September 2 in Italy. This award, called "Premio Calabria-America" is presented through the Bruzio Centre of Arts and Culture in collaboration with the port city of Gioia Tauro and the Province of Calabria.

The award is given annually to people of Calabrian origin who have distinguished themselves or have been successful in the fields of Arts and Culture, Sciences & Medicine, Sports, Education, Entrepreneurship and Politics. This was the 13th year of the award, and along with Councillor Calendino, there were a cardiologist from the US, a construction entrepreneur from Buenos Aries, Argentina, a molecular scientist from the University of Leicester in England and a reporter of the Italian state TV network – RAI International from New York.

Mayor Corrigan advised that Councillor Calendino had also been given a warm reception by the Mayor and Council of his hometown of Mangone, Italy. On behalf of Council and the citizens of Burnaby, Mayor Corrigan extended congratulations to Councillor Calendino.

A) Wendy Lynn Hankin, 1705-9595 Erickson Drive, Burnaby, appeared before Council to ask for the revocation of the licence to operate the patio at Anducci's Restaurant in Cameron Plaza and to request a review of Burnaby's Noise Bylaw.

Ms. Hankin noted the following two conditions of the patio license: there is to be no music or entertainment on the outdoor patio and the patio must be closed by 10:00 p.m. The speaker advised that the restaurant owner is not being cooperative in enforcing these conditions and that the response from the City of Burnaby when she calls to register a complaint has also not been hospitable.

The speaker shared her belief that mixed-use developments don't work. Also, that densification and issues related to higher density development caused the City of Vancouver to do a review of their bylaws in order to address change. In conclusion, Ms. Hankin asked the City of Burnaby to undertake a review of its current bylaws, particularly in relation to noise.

A) Community Heritage Commission
Re: Burnaby Community Heritage Register
2006 Project Update

The Community Heritage Commission submitted a report providing an update on the creation of the Burnaby Community Heritage Register. The completed published document "Burnaby's Heritage" will be an inventory of the City's heritage resources and will provide substantial new information for the City and community to assist manage heritage resources. The document, which will be available in print and on the web, will provide Burnaby's heritage program with the essential information needed to proceed with the development of a comprehensive heritage management program and the community will benefit

due to information about heritage sites being much more widely accessible. A more detailed policy and procedures report for the management of the heritage resource inventory, as part of the Burnaby Community Heritage Register, will be the subject of a future report to Council.

The Community Heritage Commission recommended:

1. THAT Council approve the expenditure of \$15,000 from the Annual Budget of the Community Heritage Commission to print copes of "Burnaby's Heritage" and to make information web accessible, as outlined in this report.

B) Community Heritage Commission Re: Burnaby Historic Photograph Online Database

The Community Heritage Commission submitted a report outlining a proposal to establish a Burnaby Historic Photograph online database under the auspices under the City Archives. The proposed Historic Photograph Database project is intended to be inclusive of all collections: including the City of Burnaby (12,600 photographic images); the Burnaby Village Museum (2,600 historic photographs); and the Burnaby Community Archives Collection currently maintained by the Burnaby Historical Society (5,000 photographic images). This will create new partnerships for the conservation and interpretation of Burnaby's heritage.

The Community Heritage Commission recommended;

- 1. THAT Council approve the revised mandate for the City Archives to include community records.
- 2. THAT Council approve an expenditure of \$10,000 from the Community Heritage Commission budget to complete Phase I of the Burnaby Historic Photograph Online Database, as outlined in this report.

C) Transportation Committee Re: #134 Bus Service

- 2. THAT Council send copies of this report to those that have corresponded with the City on this issue, as well as P. Noriega, Manager, Service Planning, Coast Mountain Bus Company, and G. Masterton, Program Manager, TransLink.

D) Transportation Committee Re: Traffic Issues on Edmonds Street Between Griffiths Drive and Kingsway

The Transportation Committee submitted a report, advising council on issues raised in correspondence to the Transportation Committee regarding traffic on Edmonds Street between Griffiths Drive and Kingsway. Traffic issues including noise, truck and bus volumes, pedestrian and cyclist safety and traffic shortcutting on Edmonds Street between Kingsway and Griffiths have been raised in recent correspondence to the Transportation Committee. This report review issues in relation to the concerns raised and recommends measures to be taken by the City to address these issues, including the provision of truck

engine brake signing, interim sidewalks, marked crosswalks and the installation of speed humps through the resident-initiated Local Area Service Program.

The Transportation Committee recommended:

- THAT Council approve the following actions to address the concerns of the correspondents regarding traffic on Edmonds Street between Kingsway and Griffiths:
 - a. that signs be installed on Edmonds between Kingsway and Griffiths advising trucks to avoid using engine brakes.
 - b. that interim sidewalks be constructed on the north side of Edmonds in front of 7173 and 7183 Edmonds and on the south side in front of 7150 and 7170 Edmonds, as shown in Figure 1 of this report.
 - c. that residents of 18th Avenue (between Britton and Griffiths) and the residents of 16th and 18th Streets (between Edmonds and 18th Avenue) be sent information on the Local Area Service Program for speed humps.
- THAT copies of this report be forwarded to Lori Geosits, Peter Kollross and Ross Gnelty who have corresponded with the Committee on this matter.

Construction of the space for the Community Police Office is scheduled to be completed by the developer in 2006 October. The City is responsible for outfitting the space with the necessary furniture, fixtures and equipment for the Community Police Office use.
