2. THAT on receipt of the successful petitions, the City Solicitor prepare Local Area Service Construction Bylaws for each of the successful projects.


I, D.R. Comis, do hereby certify that petitions have been received supporting the following Local Area Service Streetlight projects as detailed in the attached schedule:
