RECOMMENDATION:



REPORT

Arising from correspondence received at the Traffic Safety Committee meeting held on 2006 September 05, staff was directed to report back on Mr. Hitchen's request for lighting in the lane behind 6127 Gordon Avenue. Mr. Hitchen's concerns were about dumping of garbage in area and vandalism. Staff have discussed these concerns with Mr. Hitchen's previously.

Lane lighting is requested and approved only if there are Hydro poles available to mount a fixture. The fixture and power are provided by BC Hydro on an inclusive lease basis. Staff reviewed the laneway, and found that there are no poles available along the entire lane which runs from Charing Court through to Morley Avenue (See attached Map).

As an alternative Mr. Hitchens may wish to install security lighting to illuminate the problem area in the back of his property.
