#### REPORT

#### 1.0 BACKGROUND

At its meeting of 2000 February 8, Council allocated the newly-constructed community amenity space at 6140 McKercher Avenue to Burnaby Family Life Institute (BFLI). The resultant Licence Agreement with BFLI provided the non-profit society with permission to occupy the premises for a term of five years (until December 2005) at an annual licence fee of \$1. As stipulated in the Licence Agreement, BFLI was to use the premises to provide residents of Burnaby with preventative, community-based support services focusing on strengthening individuals and families.

This report seeks approval to renew the Licence Agreement for a further five year period, under the same conditions.

# 2.0 BURNABY FAMILY LIFE INSTITUTE SERVICES AT 6140 MCKERCHER

In its request to renew the lease arrangements, BFLI reported to staff that its services at 6140 McKercher have been operating at capacity for some time. BFLI has been delivering a range of programs from the site, including those for immigrant and refugee families and for children who witness abuse, as well as infant development, family dropin, and couples communication programs. BFLI proposes to continue to offer such services, should the Licence Agreement be renewed under the same conditions as the existing agreement.

#### 3.0 CONCLUSION

Staff recommend that Council approve renewal of lease arrangements with Burnaby Family Life Institute for the City-owned community amenity space at 6140 McKercher on the following terms:

- that the society continue to offer Burnaby residents preventative, community-based support services focusing on strengthening individuals and families from the site;
- that the society pay the City an annual licence fee of \$1 for occupying the premises; and
- that the lease term be set at five years.

It is further recommended that a copy of this report be forwarded to Ms. Jeanne Fike, Executive Director of Burnaby Family Life Institute.
