SUBJECT:

PROPERTY TAX INFORMATION FEES

PURPOSE:

To obtain Council approval for an increase in the fee for written property tax

information.

RECOMMENDATION:

1. THAT Council, by bylaw, establish a \$30.00 fee for providing written property tax information.

REPORT

The Tax Office currently charges \$20.00 to provide written tax information by mail, at the counter, facsimile or phone. Owners are not charged for information on their own properties. These rates were set by Council on 1997 March 03.

Staff proposes an increase to the fee for providing written property tax information by mail, at the counter, facsimile or phone to \$30.00.

We are recommending this change in rates as we have not had an increase in almost 10 years.

A. COST OF PROVIDING TAX INFORMATION

Costs include materials, staff time for researching, processing, assembling, printing, mailing or faxing, maintaining prepaid accounts, processing payments, daily balancing and programming changes.

Fees will not apply to the annual utility statement sent in February or to the annual tax statement sent to each property owner in May, or to owners requesting written information on their own property. No charge will apply to tax information given verbally.

B. FEES IN OTHER G.V.R.D. MUNICIPALITIES

A survey of fees for tax information in other G.V.R.D. municipalities is attached in Schedule 1. The survey indicates that out of twenty (20), thirteen (13) charge more than Burnaby's existing

rate, four (4) charge the same rate as Burnaby and two (2) currently charge lower rates (some are currently reviewing their rates).

Staff recommend that the proposed changes be implemented from 2007 January 01.
