'Open' Council Minutes 2006 August 28

A) Mr. Kevan J. Ridgway, President & CEO, and Ms. Shawna Deagle, Director Community Relations, Vancouver, Coast & Mountains Tourism Region appeared before Council to present an overview of the tourism industry in the Province of B.C. through video presentation. Mr. Ridgway highlighted statistics on visitor volumes and revenues as well as conversion studies which included statistics on the average length of stay, party size and expenditures per person per day.

The speaker provided background information on the regional destination marketing organization Vancouver, Coast & Mountain Tourism Region. The organization is contracted by Tourism B.C. to deliver cooperative marketing campaigns aimed at moving people through the province and encouraging overnight stays. The delegation advised they support communities in efforts to develop and market tourism noting that they are currently working with Tourism Burnaby with steps to build a tourism marketing plan for Burnaby.

- B) Mr. Brent Shaw was unable to attend the Council meeting and has been rescheduled to appear before Council on 2006 September 18.
- C) Mr. David Price, 6925 Mandy Avenue, Burnaby appeared before Council to request Council rescind their motion which authorized City staff to enter his property to remove and dispose of the accumulations of materials. Mr. Price also addressed the deadline of August 31, as set out in Manager's Report, Item 09, to get his property into compliance with the City's Unsightly Premises Bylaw. The speaker advised he has a new contact from the City's Licence Department and he is now aware of what has to be removed, however, two months is not a reasonable amount of time to complete the work.

Arising from the delegate's presentation, Council requested the delegate continue to work with staff to remove and dispose of the accumulations of materials. Council noted that staff will use their discretion regarding his progress asking that significant progress be made by the end of the month and for full compliance with Burnaby's Unsightly Premises Bylaw on or before the end of September.

1. 2006 Access Improvements To City Facilities

The City Manager submitted a report from the Director Planning and Building seeking Council approval for a Capital Expenditure Bylaw to be brought down to finance accessibility improvements at various City facilities in 2006. The Burnaby Access Advisory Committee, in conjunction with contacts from various City departments, propose improvements at Eileen Dailly Leisure Pool, C.G. Brown Pool, Shadbolt Centre, various City playgrounds and the main detachment of the RCMP.

The City Manager recommended:

1. THAT a Capital Expenditure Bylaw in the amount of \$50,000 (inclusive of 6% GST) be brought forward to finance accessibility improvements at various City facilities in 2006, as outlined in Section 2.0 and 3.0 of this report.

Kingsway-Edmonds Mixed-Use, High-Rise Residential,
 Public Library – Site Servicing
 City Cost Share – Rezoning Reference #05-13

The City Manager submitted a report from the Director Planning and Building seeking Council approval for the City cost share contribution towards the servicing for the subdivision creating the three (3) parcels included in the subject rezoning proposal. A subdivision and rezoning are being pursued to create two parcels to be sold by the City (Lot 1a for a mixed-use commercial/high-rise residential development, and Lot 2 for a high-rise residential development. The third lot (Lot 1b) is to be retained by the City for a new public library.

The City Manager recommended:

1. THAT Council authorize an expenditure not to exceed \$690,000 (inclusive of 6% GST) for the City share of costs for servicing of the subject sites, as outlined in this report.

2. THAT Council authorize the preparation of a cost sharing agreement with Bosa Properties (Edmonds) Inc. not to exceed \$648,000 (inclusive of 6% GST and contingency) for the City's share of servicing of the subject sites, as outlined in this report.

3. Rezoning Reference #06-36 Proposed Child Care Facility at 7312 Magnolia Terrace

The City Manager submitted a report from the Director Planning and Building seeking Council authorization to forward this application to a Public Hearing on 2006 September 26. The purpose of the proposed rezoning bylaw amendment is to permit the operation of a child care facility within a commercial tenant space within a small, mixed-use building on the site. The C1 District will be retained as part of the underlying zoning of the CD District zoning so the building can revert back to C1 uses should the child care facility cease operations in the future.

The City Manager recommended:

- 1. THAT a Rezoning Bylaw be prepared and advanced to First Reading on 2006 September 11 and to a Public Hearing on 2006 September 26 at 7:30 p.m.
- 2. THAT the following be established as prerequisites to the completion of the rezoning:
 - a. The submission of a suitable plan of development.
 - b. Compliance with all requirements of the Fraser Health Authority, including the applicable sections of the Child Care Licensing regulation of the *Community Care and Assisted Living Act*.

4. Rezoning Reference #05-70
4801 Kingsway, Proposed Licensee Retail Store (LRS)
Metrotown Development Plan

The City Manager submitted a report from the Director Planning and Building recommending Council reject a proposed Licensee Retail Store (LRS) at the Centrepointe development at 4801 Kingsway in the Metrotown area. The rezoning request to establish an LRS outlet on the subject site is inconsistent with adopted Council policy pertaining to the approval of new LRS's insofar as an LDB Signature Store has yet to be established in both the Metrotown Town Centre and the Big Bend area of Burnaby. Given this fundamental inconsistency with the adopted Liquor Store Framework for Burnaby, staff is recommending that the subject rezoning request be rejected.

The City Manager recommended:

The filing of a note against Land Title will ensure that potential purchasers are informed that this property is in contravention of City Bylaws.

Staff advised it will be a full report containing all relevant information related to the City's position on this matter.

Councillor Begin

Councillor Begin noted Fall is approaching and inquired as to where the Social Issues Committee was with regard to the homeless situation, specifically whether or not the same facility as last year will be available and how information on the location will be disseminated.

Councillor Jordan, Chair, Community Development Committee, advised information will be forthcoming on the status of the homeless shelter. Councillor Jordan also noted that an announcement on the housing strategy from BC Housing is imminent and will impact the financing of all housing in the Province.

Councillor Dhaliwal

Councillor Dhaliwal referred to an item of correspondence addressed to Mayor Corrigan from the Dean of the Faculty of Education at Simon Fraser University expressing their concern about the increased publicity given to the BC Elementary School Report Card prepared by the Fraser Institute. The Report Card rates and ranks elementary schools, which SFU and other stakeholders in the Province believe is inappropriate and potentially damaging. The correspondence, which was circulated to all of the members of Council and the Burnaby School Board, included a report on the matter entitled "Cautions About Rating BC's Schools". Councillor Dhaliwal inquired as to whether or not the City had received a response from the School Board.

Arising from consideration of the inquiry, Council requested the City obtain a response on this matter from the Burnaby School Board.
